

As per the letter read as 6<sup>th</sup> paper above the Director of Collegiate Education has requested to issue clarification regarding the appointment of teachers against certain deputation vacancies. Government have examined the matter in detail and are pleased to order that in future the deputation vacancies in Government colleges will be filled from the candidates included in the list of guest lecturers available with concerned Deputy Directors and paid from Government exchequer as per the rate fixed as per Government Order read as 3<sup>rd</sup>, 4<sup>th</sup> and 5<sup>th</sup> papers above according to nature of vacancies and qualifications prescribed. In the case of Aided Colleges, the deputation posts will be filled by the management by qualified guest lecturers and the details of the person selected with supporting documents must be furnished to the concerned Deputy Director of Collegiate Education immediately and remuneration paid from Government exchequer as per the rate fixed in the Government Orders read as 3<sup>rd</sup>, 4<sup>th</sup> and 5<sup>th</sup> paper above according to nature of vacancies and qualification prescribed till the regular hand return to the parent institution after deputation. In the case of deputation where University Grants Commission is reimbursing the salary of guest/substitute teachers they will be paid the amount reimbursed by the UGC and no remuneration will be paid from the state exchequer.


