

ORDER

Government have approved the Prospectus KEAM 2015 for Admission to Professional Degree Courses (Medical , Agriculture , Veterinary , Fisheries, Engineering & Architecture Courses) for the year 2015 , vide G.O read as first paper above.

As per G.O read as second paper above Government have issued orders for excluding Creamy Layer from the SEBC for reservation in admission to Professional Degree Courses based on the report of Kerala State Commission for Backward Classes and to modify the Clause 5.4.2 of the Prospectus for KEAM 2015

As per the letter read as third above , the Commissioner for Entrance Examinations requested Government to replace the word Annexure III in the Clause 5.4.2 as Annexure V .Therefore the Clause 5.4.2 of the Prospectus for the KEAM 2015 modified as :

Candidates belonging to Socially and Educationally Backward Classes (SEBC) should produce a certificate to the extent that the candidate belongs to the community which is designated as a Socially and Educationally Backward Class and does not belong to the category of Creamy Layer , in the proforma given as Annexure V of GO (P) No. 1/2015/BCDD ,dated : 01.01.2015.

Similarly ,the Clause 9.7.5 of the Prospectus for the KEAM 2015 is modified as :

To qualify in the Entrance Examination and thereby become eligible to figure in the ranklist for Engineering / Medical / Ayurveda , a candidate has to score a minimum of 10 marks each in Paper I and Paper II of the concerned Entrance Examination .The candidates who do not score the minimum stipulated marks will not find a place in the Rank list . Such Candidates will be shown as ' Disqualified ' .

Candidates disqualified in Medical Entrance Examination are not eligible for admission to the Medical & Allied courses and candidates disqualified in Engineering Entrance Examination are not eligible for admission to the Engineering Courses .

For SC/ST candidates there is no requirement of minimum marks in the Entrance Examination except for MBBS / BDS courses . There is no change in clause 9.7.5 (i) & (ii) of the Prospectus KEAM 2015.
