(എ) സംസ്ഥാനത്ത് ഏതെല്ലാം ജന വിഭാഗങ്ങൾക്കാണ് ഇപ്പോൾ സൗജന്യ വൈദ്യുതി കണക്ഷൻ നൽകുന്നത്;

(എ) ലൈൻ ദീർഘിപ്പിക്കൽ ആവശ്യമില്ലാത്ത ഗാർഹിക വൈദ്യുതി കണക്ഷനുകൾ, ആയിരം വാട്ട്സ് കണക്ടഡ് ലോഡുള്ള എസ്.സി/എസ്.റ്റി വിഭാഗങ്ങൾക്കും അഞ്ചു വാട്ട്സ് വരെ കണക്ടഡ് ലോഡുള്ള ബി.പി.എൽ അപേക്ഷകർക്കും സൗജന്യമായി വൈദ്യുതി കണക്ഷൻ നൽകി വരുന്നു.

(ബി) സൗജന്യ വൈദ്യുതി കണക്ഷൻ നൽകുന്നതുമായി ബന്ധപ്പെട്ടുള്ള മാർഗ്ഗ നിർദ്ദേശങ്ങൾ വിശദമാക്കുമോ; ഉത്തരവുകളുടെ പകർപ്പുകൾ ലഭ്യമാക്കുമോ?

(ബി) 1000 വാട്ട്സ് വരെ കണക്ടഡ് ലോഡുള്ള എസ്.സി./എസ്.ടി.വിഭാഗത്തിലുള്ള വ്യക്തികൾക്കും, 500 വാട്ട്സ് വരെ കണക്ടഡ് ലോഡുള്ള ബി.പി.എൽ വിഭാഗത്തിലുള്ള വ്യക്തികൾക്കും (ലൈൻ നീട്ടൽ ആവശ്യമില്ലാത്ത) വൈദ്യുതി കണക്ഷൻ, സൗജന്യമായി നൽകുന്നുണ്ട്. കൂടാതെ കേന്ദ്രാവിഷ്കൃത പദ്ധതിയായ രാജീവ് ഗാന്ധി ഗ്രാമീണ വൈദ്യുതീകരണ പദ്ധതിയിൽ ഉൾപ്പെടുത്തി 01.12.2014 വരെ അപേക്ഷിച്ച എല്ലാ ബി.പി.എൽ അപേക്ഷകർക്കും പൂർണ്ണമായി സൗജന്യമായും പ്ലിന്ത് എരിയ 1000 Sqft.നു താഴെയുള്ള എ.പി.എൽ അപേക്ഷകർക്ക് വെതർ പ്രൂഫ് ഭാഗത്തിന്റെ മാത്രം എസ്റ്റിമേറ്റ് തുക ഈടാക്കി ഓവർഹെഡ് ലൈൻ സൗജന്യമായി നിർമ്മിച്ച് കൊണ്ടും കണക്ഷൻ നൽകിയിട്ടുണ്ട്. കൂടാതെ തിരുവനന്തപുരം, കോട്ടയം, എറണാകുളം, തൃശ്ശൂർ എന്നീ ജില്ലകളിൽ

മേൽപറഞ്ഞ വിഭാഗങ്ങൾക്ക് 30.09.2015 വരെ തുടർന്നും കണക്ഷൻ നൽകുന്നതിന് ഉത്തരവ് നൽകിയിട്ടുണ്ട്.

കൂടാതെ ഈ 4 ജില്ലകളിൽ രാജീവ് ഗാന്ധി ഗ്രാമീണ വൈദ്യുതീകരണ പദ്ധതി കഴിയുമ്പോഴും മറ്റ് 10 ജില്ലകളിൽ കേന്ദ്ര സർക്കാർ പുതുതായി ആവിഷ്കരിച്ചിരിക്കുന്ന പദ്ധതിയായ ദീന ദയാൽ ഉപാദ്ധ്യായ ഗ്രാമ ജ്യോതി യോജന (ഡി.ഡി.യു.ജി. ജെ.വൈ)-ൽപ്പെടുത്തിയും ബി.പി.എൽ അപേക്ഷകർക്ക് സൗജന്യമായി ഓവർഹെഡ് ലൈനും വെതർ പ്രൂഫും നിർമ്മിച്ച് കണക്ഷൻ നൽകുന്നതിനുള്ള നടപടികൾ സ്വീകരിച്ച് വരുന്നു.

CIRCULAR

Sub: Centrally Aided Projects-RGGVY XI plan and DDUGJY schemes -reg.

- Ref: 1. Letter No. REC/TVPM/RGGVY/Time Extn/15-16/73 dated 08.05.15 of the Chief Project Manager, REC Ltd, Trivandrum.
2. BO. (FTD) No. 1744/2014 (KSEB/TRAC/Supply Code 2014/R2/2014) dated 26.06.2014.

Several complaints have been received that various section offices have not been entertaining requests from BPL/ST consumers pointing out that RGGVY scheme has closed and DDUGJY scheme has not yet commenced. This puts such consumers in a position wherein they have to make huge remittance for posts and strengthening of distribution infrastructure.

M/s Rural Electrification Corporation Ltd has intimated vide letter under ref.(1) that, Competent Authority has agreed to continue RGGVY XI Plan Projects till 30.09.2015, so that the works under RGGVY scheme in Thiruvananthapuram, Kottayam, Ernakulam, and Thrissur districts which were not closed can be executed till 30.09.2015. Hence all the domestic service connections including BPL, APL and Village Electricity infrastructure works are to be executed till 30.09.2015 as per the guidelines of RGGVY and within the sanctioned scheme amount. *(APL service connections are to be effected only from the infrastructure created for such BPL service connections after realizing the cost for the WP portion).* The closure proposal of these 4 schemes shall be furnished by 10.10.2015 positively.

In the remaining 10 districts viz. Kollam, Pathanamthitta, Alapuzha, Idukki, Malappuram, Palakkad, Wayanad, Kozhikode, Kannur, and Kasargod, all BPL service connections both OH and WP shall be effected under DDUGJY scheme. If the sanctioned amount of RGGVY is exhausted in Thiruvananthapuram, Kottayam, Ernakulam, and Thrissur districts, then the BPL service connections both OH and WP in these districts shall also be effected under DDUGJY. The progress of BPL service connections thus given shall be booked under DDUGJY upon sanction of the scheme

from Ministry of Power, Govt. of India, which is being awaited. A separate register with details of the service connections effected under DDUGJY shall be maintained for future purpose.

Under no circumstances should connection to BPL families in all 14 districts withheld citing that RGGVY has expired and DDUGJY has not commenced. All BPL category applicants irrespective of their connected load both OH and WP are to be extended the benefit of free electricity supply as was being done when RGGVY was in place. The WP service connection to the SC/ST consumers with connected load below 1000 Watts are to be effected as already directed vide BO cited under ref (2) above (*If these applicants fall under BPL category, then the service connections shall be booked under DDUGJY*).



ORDER

In the Board Order read as 1st paper above, it is stated that while reviewing the status for implementation of RGGVY and R-APDRP Schemes, it was noted that BPL category applicants throughout the State except entire Idukki District, Corporations and Municipality areas in the other 13 Districts are being given the facility of electric connection without levying cost. Hence the Board ordered that the BPL category applicants of the above areas shall also be provided electric connection without realizing cost both for over head and weather proof portions.

Vide Board Order read as 2nd paper above, the Board ordered to effect all the Domestic APL category service connections registered up to 15.11.2014 under Electrical Circle, Thodupuzha by constructing OH portion, without collecting any cost and realizing cost for WP portion, as part of the total electrification programme, since no RGGVY scheme is at present exist in Idukki District.

As per the Board Order read as 3rd paper above, the Board extended the time limit for executing all the RGGVY sanctioned projects till 15.11.2014. In the Board Order it is stated that the prime objective of the project is to electrify maximum number of rural BPL households.

Certain doubts were being raised from the field offices whether service connections under APL category can be given as per the directions mentioned in the Board Orders above and also whether the service connections registered as on 15.11.2014 can be effected thereafter.

Hence the field officers were directed vide letter read as 4th paper above that

1. All the OH & WP domestic service connections registered under BPL category in the 13 RGGVY Districts and in Idukki District till 30.11.2014 shall be effected immediately on registration without realizing cost of service connection.

2. Under APL domestic OH & WP category, service connections to those premises having plinth area less than 1000 sq.ft and the service connections registered till 30.11.2014 shall also be effected immediately after realizing the cost for WP portion alone, and after getting a self certified affidavit by the applicant to the effect that if on verification, plinth area exceeds 1000sq.ft, they shall remit the entire cost.

3. Under both the above category, no restriction for the length of OH line.

4. For APL category having plinth area above 1000 sq.ft and flats, connections shall be effected on realizing the cost for entire portion.

The matter was placed before the Full Time Directors vide note read as 5th paper above.

Having examined the matter in detail, the Full Time Directors in the meeting held on 28.11.2014 decided:

1. to ratify the action of the Director (Distribution & Safety) in issuing direction to the field officers as detailed above, and
2. to direct the field officers to effect all such service connections registered up to 30.11.2014 by 15.12.2014.

Orders are issued accordingly.


