

ORDER

In partial modification of the Government Order read as 2nd paper above, Government are pleased to modify the existing powers to sanction tender excess over revised SoR 2010 as specified in the table in Para (1) therein as follows:

Sl. No.	Designation	Works within the TS Power of AEE/EE	Works within the TS Power of SE	Works within the TS amount of ₹ 2 Crore
1	Executive Engineer	5%
2	Superintending Engineer	10%	5%	..
3	Chief Engineer	15%	10%	5%

2. In the case of works having technical sanction up to ₹ 750 lakhs tender excess upto 10% over revised SoR 2010 will be approved by the Administrative Department with the approval of tender committee. The minutes of tender committee shall be got approved by Minister (Works) and Minister (Finance).

3. The works having tender excess over revised SoR 2010 beyond the limits specified in Para (1) & (2) above (in respect of works having TS amount below ₹ 750 lakhs) will be accepted by the Administrative Department with the concurrence of Finance Department.

4. Tenders of all works having technical sanction above ₹ 750 lakhs will be accepted by Administrative Department with the concurrence of Finance Department.

5. Government Orders read above stand modified to the above extent.

6. The above powers will stand withdrawn as and when the next SoR comes into force.

ORDER

In the Government Order read above, Government issued orders modifying powers of Technical Officers of Engineering Department regarding acceptance of tender excess and sanction of revised estimates. The modifications were ordered till next SoR come into force.

The Chief Engineer (Admn.) has pointed out that certain restrictions in sanctioning revised estimates in the above said order causes delay in execution of works. The Empowered Committee chaired by Secretary (PWD) in its meeting held on 1-10-2011 has reviewed the position and recommended to modify the powers of Chief Engineer as follows:

- (i) To sanction increase up to 10% of the estimated cost on foundation works of bridges and buildings for projects costing up to ₹ 10 Crore.

- (ii) To sanction tender excess of works having technical sanction up to ₹ 3 Crore.
- (iii) To continue the existing powers in sanctioning revised estimates.


Government have examined the matter in detail and pleased to modify the existing powers referred in the G. O. cited accordingly. The above delegation cease to exist as and when next SoR comes into force and delegation now given on foundation works will expire by 31-3-2012.
