### OR DER

The Director of Technical Education vide letter read above has requested Government to enhance the remuneration of Guest faculty and Technical employees in the Government Engineering Colleges.

Government have examined the matter in detail and are pleased to revise the remuneration of Guest faculty and Technical employees of Government Engineering Colleges as given below.

- a. Guest faculty with PG qualification (other than B.Tech) without NET shall be paid Rs. 500/- per hour subject to a maximum of Rs. 20,000/- (rupeess twenty thousands only) per month. (ie, for the faculty who deal subjects like Maths, physics, Chemistry and such other subjects which need not require basic engineering degree).
- b. Guest faculty with PG qualification (other than B.Tech) and with NET/M.Phil/Ph.D or teaching experience of more than 3 years in AlCTE recognized institutions in the relevant subject shall be paid Rs. 600/- per hour subject to a maximum of Rs. 22,000/-(rupees twenty two thousands only) per month.
- c. Guest faculty with B.Tech/M.Tech and teaching in UG classes only will be paid Rs. 750/- per hour subject to a maximum limit of Rs. 23,000/- (rupees twenty three thousands only) per month.
- d. Guest faculty who have qualification equivalent to the post of Assistant Professor and qualification for teaching in PG classes but teaching in UG and PG classes will be paid Rs. 1000/- per hour subject to a maximum of Rs. 25,000/-( rupees twenty five thousands only ) per month.
  - e. The date of effect of the benefit shall be from 1.6.2012.
- f. No TA/DA will be paid to the guest faculty. They shall do the Lab works and other connected works assigned to them as stipulated in G.O (P).No.5/2001/H.Edn dated 3.1.2001 besides the teaching hours.
- g. The ratio prescribed as per G.O(MS) 61/02/H.Edn dated 17.6.2002] for calculating work load ie One hour of teaching(theory class) for PG shall be equal to 1.5 hours is not applicable to the case of guest faculty.

- h. The maximum limit for payment for teaching shall be limited to 4 hours, in a day, for a guest faculty.
- i. Selection and allotment of guest faculty shall be done by the HOD/Division of the college/University and the same shall be approved by the Department Council/Council of Teachers Division.
- j. The Principal/Head of the institution will intimate to the DTE the requirement of teaching staff for an academic year to be appointed as guest lecturer based on the workload and get approval for the same.
- k. Guest faculty will not be treated as regular teachers and are not entitled to any additional benefits like annual increments/non compound increments, career advancement benefits, any other allowances, pension etc. They will be appointed for an academic year and they may be re-appointed, if required.
- In the absence of qualified teachers, retired teachers up to the age of 70 will be considered for appointment as guest faculty.
- m. The guest lecturer shall attend to all work assigned to the sanctioned post against which they are appointed.
- n. The remuneration of the instructor/work shop instructor shall be enhanced to Rs. 300/- per hour. But their maximum monthly remuneration shall be limited to the minimum of the basic pay in the scale of pay of the post.
- o. Tradesman/Trade instructor will be eligible for a sum of Rs. 200 per hour. But their maximum monthly remuneration shall be limited to the minimum of the basic pay in the scale of pay of the post.
- p.The terms and conditions prescribed above for guest faculty will be equally applicable to instructor/work shop instructor and Tradesman/Trade instructor.
