#### ORDINANCE No. 11 OF 2020

### THE KERALA LABOUR WELFARE FUND (AMENDMENT) ORDINANCE, 2020

Promulgated by the Governor of Kerala in the Seventy-first Year of the Republic of India.

#### AN

#### ORDINANCE

further to amend the Kerala Labour Welfare Fund Act, 1975.

*Preamble.*—WHEREAS, the Kerala Labour Welfare Fund (Amendment) Ordinance, 2020 (8 of 2020) was promulgated by the Governor of Kerala on the 16th day of January, 2020;

AND WHEREAS, a Bill to replace the said Ordinance by an Act of the State Legislature could not be introduced in, and passed by, the Legislative Assembly of the State of Kerala, during its session which commenced on the 29th day of January, 2020 and ended on the 12th day of February, 2020;

AND WHEREAS, under sub-clause (a) of clause (2) of Article 213 of the Constitution of India the said Ordinance will cease to operate on the 11th day of March, 2020;

AND WHEREAS, difficulties will arise if the provisions of the said Ordinance are not kept alive;

AND WHEREAS, the Legislative Assembly of the State of Kerala is not in session, and the Governor of Kerala is satisfied that circumstances exist which render it necessary for him to take immediate action;

NOW, THEREFORE, in exercise of the powers conferred by clause (1) of Article 213 of the Constitution of India, the Governor of Kerala is pleased to promulgate the following Ordinance:—

1. *Short title and commencement.*—(1) This Ordinance may be called the Kerala Labour Welfare Fund (Amendment) Ordinance, 2020.

(2) It shall be deemed to have come into force on the 16th day of January, 2020.

2. Act 11 of 1977 to be temporarily amended.—During the period of operation of this Ordinance, the Kerala Labour Welfare Fund Act, 1975 (11 of 1977) (hereinafter referred to as the principal Act) shall have effect subject to the amendments specified in section 3.

3. Amendment of section 15.—In the principal Act, in sub-section (1) of section 15,—

- (i) for the words "four rupee", the words "forty five rupees" shall be substituted;
- (ii) for the words "eight rupees", the words "forty five rupees" shall be substituted.



4. *Repeal and saving.*—(1) The Kerala Labour Welfare Fund (Amendment) Ordinance, 2020 (8 of 2020) is hereby repealed.

(2) Notwithstanding such repeal, anything done or any action taken under the principal Act as amended by the said Ordinance shall be deemed to have been done or taken under the principal Act, as amended by this Ordinance.
