# Order No 739/A2/KRSA/2016 Dated: 26/02/2017

As per letter read as first paper above, based on the request from Sri C Divakaran MLA the District Collector, Trivandrum had submitted proposal received from KELTRON forwarded by the State Police Chief for the installation of the Traffic Signal Lights at Junctions of Nedumangad, Vembayam, Pothenkode, Market and Pazhakutty, for a total estimated cost of Rs. 42,77,321/- (Forty two lakhs seventy seven thousand three hundred and twenty one only). The split-up is as follows

1 Solar Powered Traffic Signal System at vembayam

Rs 11,03,487/-

2 Solar Powered Traffic Signal System at Pothencode

Rs. 13,14,643/-



3 Conventional Powered (230 V AC) Traffic Signal System

at Market junction

4 Conventional Powered (230 V AC) Traffic Signal System

at Pazhakutty

Rs. 8,46,122/-

The 32<sup>nd</sup> Kerala Road Safety Authority meeting held on 18.02.2017 decided (copy enclosed) to sanction an amount of Rs. 42,77,321/- (Fourty Two Lakh Seventy Seven Thousand three Hundred and twenty one only) for installing the Traffic Signal Lights at Junctions of Nedumangad, Vembayam, Pothenkode Market and Pazhakutty Thiruvananthapuram and to entrust the works to KELTRON subject to the conditions that if KELTRON resort to outsourced goods and services for implementing the projects, the following conditions must be followed.

KELTRON may purchase all bill of materials / services through Government of Kerala's e-tender system and KELTRON shall levy TSP charges only for outsourced goods and services.

The 19<sup>th</sup> Kerala Road Safety Authority Meeting held on 06.11.2013 decided to entrust the ownership of Traffic Signals at various junctions to Police Department.

In the circumstances sanction is hereby accorded to draw and disburse an amount of Rs. 42,77,321/- to the State Police Chief, Kerala, Thiruvananthapuram by Treasury Cheque being the amount for installing the Traffic Signal Lights at Junctions of Nedumangad, Vembayam, Pothenkode, Market and Pazhakutty Thiruvananthapuram as proposed vide reference 1<sup>st</sup> cited. The funds now allotted will be transferred to the Managing Director, Keltron to whom the work of installation of Traffic Signal has been entrusted, after executing a contract agreement by the Police Department and M/s KELTRON authorities. All points regarding terms and conditions, warranty etc. should also be included in the agreement. The maintenance and of the assets created would be the responsibility of Police Department.

Interest bearing Savings Bank Account should be opened for the Road Safety Fund allotted and the amount released should be deposited in that account only and the account number will be communicated to the under signed forthwith. Separate Cash Book will be maintained for the road safety fund allotted and voucher for each expenditure met from the funds should be kept for audit. The Utilization Certificate with statement of expenditure should be furnished to the under signed within one month from the date of completion of the project and the balance of fund with interest, if any, allotted for the projects should be refunded along with detailed Utilization Certificate. Non observances of the above instructions will be viewed seriously and further road safety funds will not be released. It is also interest to submit the Utilization Certificate for an

amount of Rs.2440522/- also allotted to Sate Police Chief as per the decision in 22<sup>rd</sup>
Meeting held on 17/10/2014

The expenditure in this regard will be met from the funds available in the Special TSB Account Number 168 of Road Safety Authority maintained at District Treasury, Thiruvananthapuram.
