### ORDER

As per the letter read as 1<sup>st</sup> paper above, the Director, ANERT requested Government to accord Administrative Sanction for the implementation of the project viz. "Electrification Programme Using Renewable Energy Sources" for an amount of Rs. 2898 lakh provided in the Annual Plan 2016- 17 of ANERT.

2. The Special Working Group Meeting held on 18.10.2016 examined the project proposals with reference to the plan write up and approved the project. But as per the letters read as 3<sup>rd</sup> and 4<sup>th</sup> papers above, the Director, ANERT forwarded a revised project proposal and has requested Government to accord Administrative Sanction for the implementation of the same.

3. The Special Working Group Meeting held on 15.11.2016 examined the revised project proposal of ANERT and has approved the same.

4. Government have examined the matter in detail and are pleased to accord Administrative Sanction for an amount of Rs.2898lakh (Rupees twenty eight thousand nine hundred and ninety eight lakh only) for implementing the projects using Renewable Energy Sources as detailed in the annex.

5. The expenditure in this regard will be met from the Head of Account 2810-00-800-90(02).

6. The fund will be released during the financial year 2016-17 based on the actual requirement and subject to the following general conditions.

General Conditions

1. The expenditure would be met from the provision available under the appropriate head of account for the purpose mentioned above.
2. The fund release will be based on actual requirement and fund released should not be parked in Banks and should be utilized in the current financial year itself.
3. Store Purchase Rules shall be strictly adhered to.
4. Tender/e-tender and other stipulated formalities shall be followed wherever necessary.
5. For civil works, CPWD rates shall be followed.
6. Post creation and purchase of vehicles are not admissible under the scheme.
7. ANERT, the implementing agency, will monitor and implement the programmes through the District Offices of ANERT.

**Subject: Release of CFA to Agency for Non-Conventional Energy & Rural Technology, Kerala (ANERT) for implementation of grid connected SPV power plants of aggregate capacity of 5.0 MWp in different locations in Kerala under NCEF project of 54 MWp**

Sir,

In continuation to this Ministry's sanction letter no. 5/38/2013-14/RT dated 27.10.2014 the sanction of president of India is hereby conveyed for release of central financial assistance amounting to Rs. 3,60,00,000/- ( Rupees Three Crore Sixty Lakh only) to Agency for Non-Conventional Energy & Rural Technology, Kerala (ANERT) as advance for implementation of 5 MWp rooftop solar PV plants on different buildings in the State of Kerala under the above mentioned programme within the approved CFA of Rs. 12,00,00,000/- .

2. The cost of the project should be firmed up through a transparent process and the actual amount of subsidy will be 30 % of the actual cost or Rs. 24 per watt , whichever is lower .
3. The release of further installments will be considered after submission of requisite claims, submission of project completion reports, utilization certificate and Audited Statement of Expenditure. ANERT will also make the sites/premises available for inspection by MNRE or its designated team/agency.
4. ANERT will follow all the terms and conditions stipulated in the letter no. 5/38/2013-14/RT dated 27.10.2014 and as amended time to time.
5. This Ministry may also be kept apprised about the status of the development of the project related activities from time to time. The funds being released may be kept in the interest bearing account and the interest accrued may be credited towards the Govt.

Account. ANERT will also submit the audited Statement of Expenditure (SoE) and Utilization Certificate (UC) in the prescribed format of GFR 19 (A).

6. The grants-in-aid will be regulated in accordance with the provision contained in the Terms and Conditions of Ministry of New and Renewable Energy. The grant-in-aid is also subject to the Chapter 9 of the General Financial Rules, 2005, as amended from time to time, read with the Government of India's decisions incorporated there-under, and any other guidelines which may be issued in this regard, and in particular to the following conditions:

- i) The pattern of assistance of rules governing such grants-in-aid has received the approval of the Ministry of Finance, as required under Govt. of India Decision No. (1) under DFPR- Rules 20.
- ii) Assets acquired wholly or substantially out of Government Grants shall not be disposed of without obtaining the prior approval of the sanctioning authority of grants-in-aid.
- iii) The accounts of ANERT shall be audited by C&AG or by any person authorized by him on his behalf in accordance with the provisions laid down in Section 14 of the C&AG (DPC, 1971) as amended from time to time.
- iv) The accounts of ANERT shall be open for inspection by the sanctioning authority and audit, both by the Comptroller & Auditor General of India under the provision of C&AG (DPC) Act, 1971 and internal audit party by the Principal Accounts Office of the Ministry or Department whenever it is called upon to do so.

With reference to the proposal from ANERT vide letter No. dated 19.09.2014 on the above cited subject and this Ministry's guidelines for Off Grid and Decentralised solar applications Programme during 12<sup>th</sup> plan, I am directed to convey the sanction of the President for Central Financial Assistance (CFA) of Rs.46,35,00,000/- (Rupees Forty Six Crore Thirty Five Lakh Only) to ANERT, Trivandrum towards installation of SPV Power plants with aggregate capacity of 10MW at individual households/ schools/govt. Institutions and other establishments in the state of Kerala. The above sanction also include Rs.1,35,00,000/- (Rupees One Crore Thirty Five Lac only) towards service charges to ANERT

2. The sanction of the CFA will be subject to the provisions of the Ministry's Guidelines No.30/11/2012-13/NSM dated 26<sup>th</sup> May 2014 and No.5/23/2009-P&C (Part-III) dated 3<sup>rd</sup> November 2014

3. The sanction is subject to fulfillment of following conditions

**Technical:**

- a. ANERT will implement the project through open tender.
- b. The Battery capacity must be @7.2VAH/Wp. Less capacity battery systems will be treated as battery less systems
- c. The systems must have three years CMC apart from two year warranty. Without CMC the users are not allowed to avail CFA
- d. ANERT also include remote monitoring mechanism

4. I am also directed to convey the release of **Rs.13,50,00,000/- (Rupees Thirteen Crore Fifty Lac Only)** to ANERT towards first installment of CFA under the project. The CFA will be released after clearing pending UCs by ANERT

5. ANERT will maintain and present their Annual Accounts in the standard format as required under GFR 209 (xiii). These accounts shall be open for inspection by the sanctioning authority and audit, both by the Comptroller & Auditor General of India under the provision of C&AG (DPC) Act, 1971 and internal audit party by the Principal Accounts Office of the Ministry, whenever called upon to do so.

6. The project completion period will be as per para 7.1 of guidelines no 30/11/2-12-13/NSM dated 26<sup>th</sup> May 2014, **With all applicable penalties, the sanction validity is twenty four months from the date of issue.**


