The Hon'ble Chancellor therefore desires to convey that no steps shall be taken to meet the legal expenses to the Officers of the University for the legal proceedings, as mentioned in Para 1 above, against the Chancellor/University and if any such payments have already been made, the amount shall be recovered forthwith from the concerned Officer, on whose behalf the payment was made.
