In the Revised Budget Speech 2016-17, Government had announced 'Construction of new office buildings for Registration Department' as a project under KIIFB funding. Administrative Sanction has been accorded, entrusting Kerala State Construction Corporation Limited (KSCC) as Special Purpose Vehicle for execution of the project, vide Government Orders read above.

Accordingly, the Detailed Project Reports (Construction of Building for Sub Registrar Offices at Kozhikode and Malappuram Districts) subsequently submitted by the Kerala State Construction Corporation Limited (KSCC) were verified and appraised for adherence to KIIFB stipulations and appraised for compliance, as per G.O(Ms) No.69/2018/Fin dated 24-02-2018. On appraisal, the projects were found satisfactory in terms of all technical and financial parameters insisted upon by KIIFB.

After considering the proposal and the appraisal report, 7th Executive Committee held on 25-04-2018 approved the project. Thus Sanction is accorded for funding the project **Tranche 8- RGD007-02: Construction of Building for Sub Registrar Offices at Kozhikode and Malappuram Districts cluster-V**, approved vide Government Order read (2) above, to be implemented by the Kerala State Construction Corporation Limited (Special Purpose Vehicle); limiting the total outlay to **Rs. 12.11 Crore (Rupees Twelve Crore and Eleven Lakh only)** against the revised proposed amount of Rs. 13.17 Crore, as noted below and also with the stipulations there under.

As per the Detailed Project Report submitted by the Special Purpose Vehicle: Kerala Infrastructure and Technology for Education (KITE), sanction has been accorded in the 7 th meeting of the KIIF Executive Committee held on 25-04-2018 for funding the project: 'HED007-02:-Augmentation of Infrastructural Facilities at Government Colleges in Kozhikode and Kannur District -Cluster Phase-1'- for a total outlay of Rs. 37.22 Crore (Rs.9.045 Cr for Kunnamangalam Government Arts & Science College, Chathamangalam; Rs.9.215 Cr for Government Arts and Science College, Nadapuram; Rs.9.917 Cr for Government Arts & Science College, Balussery and Rs.9.043 Cr for Government College Thalassery, Chokli) vide Order read 2nd above. Later, due to the changes in the design as per KMBR and NBC guidelines, in consideration of seismic factors in the design parameters, change in foundation design as per soil investigation and inclusion of GST etc. cost escalation happened for above said colleges. Accordingly, SPV submitted revised estimates based on factors mentioned above as well as due to exclusion of certain components provisioned earlier.

Having examined the proposal in detail, the funding sanction is revised, based on reference 1st cited, thereby increasing the total outlay to Rs.42.14 Crore (Rupees Fourty-Two Crore Fourteen Lakh Only) (Rs.10.13 Cr for Kunnamangalam Government Arts & Science College,

Chathamangalam; Rs.10.52 Cr for Government Arts and Science College, Nadapuram; Rs.11.11 Cr for Government Arts & Science College, Balussery and Rs.10.38 Cr for Government College Thalassery, Chokli), subject to compliance of conditions mentioned in the Order read 2nd above.

Government, through the Budget Speech 2017-18, had announced 'Upgradation of One School in each Constituency as Centre of Excellence' to be taken up as a project funded by KIIFB subsequently designating Kerala Infrastructure and Technology for Education (KITE) as the Special Purpose Vehicle for executing the project. Subsequently, Administrative sanction issued vide Government Order read above was issued for executing the project at a cost of Rs.15.98 crore.

Government, through the Budget Speech 2018-19 (Para 51), have announced project "Bettennent Infrastructure facilities of in 166 schools (Rs.3) category)" under KIIFB funding. Subsequently, Administrative sanction has been issued vide Government Order read 2nd above, entrusting 'Kerala Infrastructure and Technology for Education' (KITE) as the Special Purpose Vehicle (SPV) for executing the school projects at a cost Rs.3 Crore for each school. Later, vide Government Order read 3rd above 'Infrastructures Kerala Limited' (INKEL Ltd) have been re designated as the Special Purpose Vehicle (SPV) for executing the school projects replacing KITE. Accordingly, the SPV (INKEL Ltd) submitted Detailed Project Reports for 13 schools in Palakkad, Malappuram, Kozhikode, Kannur and Kasargod districts clustered under the sub-project "Betterment of Infrastructure facilities in 166 schools- Palakkad, Malappuram, Kozhikode, Kannur & Kasargod Cluster (Rs.3 Crore category)", which were evaluated for adherence to KIIFB stipulations, as per GO(Ms) No.315/16/Fin Dated 08.08.2016 and GO(Ms) No. 69/2018/Fin Dated 24.02.2018 and found satisfactory and compliant.

Thus, the 18th Executive Committee of KIIFB that met on 15th February 2021, after considering the proposal and appraisal report, has granted approval for funding the following 13 school projects.

Accordingly, sanction is accorded for funding the Project: 'TRAN-19: GED006-22: 'Betterment of Infrastructure facilities in 166 schools- Palakkad, Malappuram, Kozhikode, Kannur & Kasargod Cluster (Rs.3 Crore category)", to be implemented by INKEL Ltd (SPV) for a total outlay of Rs. 38,29,65,330/- (Rupees Thirty-Eight Crore Twenty-Nine Lakhs Sixty-Five Thousand Three Hundred and Thirty only) for 13 schools as mentioned above, subject to the following stipulations.

- 1. The tripartite agreement, as per KIIFB stipulations shall be entered, after which Technical Sanction shall be mandatorily issued by the TS authority.
- 2. The Technical sanction by competent authority is mandatory, before adding schedules to Tripartite Agreement and also before initiating tendering process. Technical sanction may be issued by the SPV only after incorporating the suggestions indicated in DAR and the compliance may be communicated to KIIFB prior to issuance of tenders.
- 3. The land available for each school shall be verified by TS committee with FMB sketch and ensure the minimum land is available as specified in KER Chapter IV Establishment and Maintenance of Schools GoK.
- 4. The detailed estimate submitted shall be reviewed by the TS authority considering the applicability and correctness and the relevance of Cost Index and adherence of latest PRICE schedule. LS provisions incorporated in the estimate towards any components shall be got replaced by detailed estimate while issuing TS. The detailed estimate shall also be checked against the designs and drawings developed. Documentary evidence of these actions shall be communicated to KIIFB prior to acceptance of the tenders.
- 5. Properly dimensioned architectural drawings, Structural drawings and Electrical drawings are required for the setting out and smooth hassle-free construction & maintaining steady progress of the work. Hence TS committee shall ensure the availability of above-mentioned drawings in GFC format.
- 6. The implementing authority should confirm well before execution that the designs have at least the mandatory requirements as per earthquake guidelines, so that safety and serviceability are fulfilled. If retrofitting is found necessary to the existing building in order to meet the safety requirements, provision shall also be incorporated in the respective estimates.
- 7. - 14. TS authority shall ensure the reasonable Project duration and corresponding WBS.

- The cost provisions for work alone shall be utilized for execution of work. The savings or anticipated savings from LA, QC, demolition etc. shall not be re appropriated for meeting expenditure of work proper.
- 10. Being a functioning educational institution, necessary safety measures may be taken.
- 11. As first phase funding is for civil infrastructure, procurement of equipment and other lab works will be considered as the second phase. For that Administrative Department has to form an expert committee consisting of specific lab equipment expert for evaluating the requirements of each college. Fund sanctioning for procurement of lab equipment of the colleges will be based on the technical reports of the committee. Selection of equipment along with its detailed specifications shall be forwarded to KIIFB along with the recommendations of the committee. The civil work for labs are not mentioned clearly in the DPR and hence the detailed need/necessity, requirements of stakeholder etc shall be submitted by the SPV. The SPV shall submit the proposal with due consideration of the time of completion of physical infrastructure and procurement of the equipment.
- 12. While entrusting the maintenance activities to the contractor, it shall be ensured that the

- obligation under defect liability shall be performed without any additional cost. Hence no maintenance expenditure shall be considered under original work.
- 13. Detailed Appraisal Report of KIIFB is appended for reference and it shall be taken into consideration by the TS Committee while according Technical Sanction to the Project.

ORDER

A major project namely; "Replacing Transmission mains in 174 schemes 4888 Km Promo Transmission mains", which envisages the replacement of old and out dated transmission mains for water supply schemes in Kerala.; was conditionally approved in the 28th Meeting of the KIIF Board held on 21-03-2017 on condition that the conditions set by KIIFB for project-financing would be met and that the status would be reported to the Board. The Board had also authorised the Chief Executive Officer, KIIFB to approve the projects not exceeding value of Rs.400 crore each, subject to compliance of the conditions set by KIIF for project financing and subsequent ratification of the Board.

In consonance with the Board's decisions, the Main Project "Replacing Transmission mains in 174 schemes 4888 Km Promo Transmission mains" which was further sub divided into eleven sub projects in various Circles- viz Thiruvananthapuram, Kollam, Pathanamthitta, Kottayam, Kochi, Muvattupuzha, Thrissur, Palakkad, Malappuram, Kozhikode and Kannur, for the purpose of functional clarity, were scrutinised. On scrutiny of the compliance report submitted by KWA (SPV), Replacement of Transmission Mains in Kozhikode Circle, forming an integral part of the main project and designed to avoid the interrupted water supply by reducing the leakages and bursting in the pumping main has been found compliant with KIIFB stipulations, with the following observations:

- The DPRs contain necessary details including item wise details, water supply scheme, detailed estimate etc.
- 2. The parameters studied regarding the demand are in favour of the proposed projects.
- 3. The functional design is matching with the requirement.
- 4. The engineering design has been attempted and specification has been documented.
- 5. The O& M strategy proposed is satisfactory.
- The estimate is prepared based on DSR 16. The observations in section 6 of DAR shall be ensured before TS.
- 7. The investment criteria (CBR) have been documented.
- 8. The period of completion is realistic and the WBS is based on the rational sequencing of activities with most likely durations. Details of cash flow not seen attached in the WBS. The observation in section 10.1 of DAR shall be ensured before TS.

- 9. The project management organization plans seem not satisfactory. The roles and responsibility of the project management unit is not detailed in the report.
- 10. The contract management plans are acceptable provided the documents and procedures are not in conflict with any of the rules and regulations regarding public works execution prevailing in Govt of Kerala.
- 11. The project requires clearances for road cutting from PWD etc.
- 12. No major environmental aspects are noted. The projects are beneficial to the people who are dependent on pipelines for drinking water.
- 13. The quality at different levels are reviewed by KWA. The observation in section 15 of DAR about quality management plan shall be reviewed before TS.
- 14. The risk management plan shall be one which eliminates and mitigates all time and cost overrun risk elements.

Considering the above, final approval and sanction is accorded for funding the Project: TRAN2-WRD005-130:Replacement of Transmission Mains in Kozhikode Circle (in Kozhikkode and Wayanad Districts), which comes under the main project "Replacing Transmission mains in 174 schemes 4888 Km Promo Transmission mains", approved vide Government Order read above, to be implemented by the Kerala Water Authority (Special Purpose Vehicle), for a total outlay of Rs.38.862 Crore (Rupees Thirty-Eight Crore Eighty Six Lakh and Twenty Thousand only), as noted below and also with the stipulations thereunder.

- **Project 2** Replacement of Damaged pipes: Augmentation to BWSS: Replacement of 300mm AC pipe in Distribution system **Rs. 4.196 Cr.**

Administrative Sanction for the project Construction of Regulator cum Bridge at u/s of Perincheri Kadavu across Kutiady River (Gulika Puzha) in Kozhikode District has been accorded, entrusting Kerala Irrigation Infrastructure Development Corporation Ltd (KIIDC) as the Special Purpose Vehicle for executing the project, vide Government Orders read above.

The Detailed Project Report, subsequently, submitted by Kerala Irrigation Infrastructure Development Corporation Ltd (KIIDC) was verified for adherence to KIIFB stipulations and appraised for compliance, as per GO(Ms) No.315/16/Fin dated 08.08.2016 and found that the projects have satisfied all the technical and financial parameters insisted upon by KIIFB.

4. Minutes of the 18th Executive Committee meeting of KIIFB held on 15/02/2021.

Government, through the Budget Speech 2018-19 (Para 51), have announced project "Bettennent Infrastructure facilities of in 166 schools (Rs.3) category)" under KIIFB funding. Subsequently, Administrative sanction has been issued vide Government Order read 2nd above, entrusting 'Kerala Infrastructure and Technology for Education' (KITE) as the Special Purpose Vehicle (SPV) for executing the school projects at a cost Rs.3 Crore for each school. Later, vide Government Order read 3rd above 'Infrastructures Kerala Limited' (INKEL Ltd) have been re designated as the Special Purpose Vehicle (SPV) for executing the school projects replacing KITE. Accordingly, the SPV (INKEL Ltd) submitted Detailed Project Reports for 13 schools in Palakkad, Malappuram, Kozhikode, Kannur and Kasargod districts clustered under the sub-project "Betterment of Infrastructure facilities in 166 schools- Palakkad, Malappuram, Kozhikode, Kannur & Kasargod Cluster (Rs.3 Crore category)", which were evaluated for adherence to KIIFB stipulations, as per GO(Ms) No.315/16/Fin Dated 08.08.2016 and GO(Ms) No. 69/2018/Fin Dated 24.02.2018 and found satisfactory and compliant.

Thus, the 18th Executive Committee of KIIFB that met on 15th February 2021, after considering the proposal and appraisal report, has granted approval for funding the following 13 school projects.

Accordingly, sanction is accorded for funding the Project: 'TRAN-19: GED006-22: 'Betterment of Infrastructure facilities in 166 schools- Palakkad, Malappuram, Kozhikode, Kannur & Kasargod Cluster (Rs.3 Crore category)", to be implemented by INKEL Ltd (SPV) for a total outlay of Rs. 38,29,65,330/- (Rupees Thirty-Eight Crore Twenty-Nine Lakhs Sixty-Five Thousand Three Hundred and Thirty only) for 13 schools as mentioned above, subject to the following stipulations.

- 1. The tripartite agreement, as per KIIFB stipulations shall be entered, after which Technical Sanction shall be mandatorily issued by the TS authority.
- 2. The Technical sanction by competent authority is mandatory, before adding schedules to Tripartite Agreement and also before initiating tendering process. Technical sanction may be issued by the SPV only after incorporating the suggestions indicated in DAR and the compliance may be communicated to KIIFB prior to issuance of tenders.
- 3. The land available for each school shall be verified by TS committee with FMB sketch and ensure the minimum land is available as specified in KER Chapter IV Establishment and Maintenance of Schools GoK.
- 4. The detailed estimate submitted shall be reviewed by the TS authority considering the applicability and correctness and the relevance of Cost Index and adherence of latest PRICE schedule. LS provisions incorporated in the estimate towards any components shall be got replaced by detailed estimate while issuing TS. The detailed estimate shall also be checked against the designs and drawings developed. Documentary evidence of these actions shall be communicated to KIIFB prior to acceptance of the tenders.
- 5. Properly dimensioned architectural drawings, Structural drawings and Electrical drawings are required for the setting out and smooth hassle-free construction & maintaining steady progress of the work. Hence TS committee shall ensure the availability of above-mentioned drawings in GFC format.
- 6. The implementing authority should confirm well before execution that the designs have at least the mandatory requirements as per earthquake guidelines, so that safety and serviceability are fulfilled. If retrofitting is found necessary to the existing building in order to meet the safety requirements, provision shall also be incorporated in the respective estimates.
- 7. The TS authority should strictly scrutinize each proposal and confirm that, Size, design and layout of the proposed construction (classrooms, laboratories, set back etc.) shall be in accordance with the standards like Kerala Education Acts and Rules, NBC &KPBR/ KMBR requirements (coverage, FAR etc.) and latest Govt orders and the rates are accurate and are as per PRICE and current DSR. In the case of vertical / horizontal extension to the existing buildings, it shall also be confirmed that the foundations of existing buildings are enough and safe for the proposed additional construction also. It shall also be ensured that the soil investigation report and sufficient data is available for the design of foundation of each building. Stability certificate for the same must be checked by the TS committee.
- 8. The cost provisions for work alone shall be utilized for execution of work. The savings or anticipated savings from LA etc. shall not be re-appropriated for meeting expenditure of work proper.

- 9. While entrusting the maintenance activities to the contractor, it shall be ensured that the obligation under defect liability shall be performed without any additional cost. Hence no maintenance expenditure shall be considered under original work. The Defect Liability Period of the Project shall be as per the existing Government rules.
- 10. Being functioning educational institutions, necessary safety measures may be taken while executing the work.
- 11. The SPV shall ensure that all statutory clearances are obtained before awarding the work.
- 12. The TS authority shall ensure sufficient data from soil investigation or trial pit for optimizing the foundation.
- 13. The client approval of the master plan and architectural drawings proposed shall be obtained before TS is accorded.
- 14. TS authority shall ensure the reasonable Project duration and corresponding WBS.
- 15. A report of KIIFB premised on the technical appraisal of the project is appended for reference which shall be taken into consideration by the TS Committee while according Technical Sanction to the Project.
