There were lapses such as not executing a contract agreement for that purpose nor furnishing bank guarantee by the party. However, the party furnished quarterly invoices for the period from 22-04-2019 to 21-01-2020, claiming use of the cloud solution by CDIT or its clients. Even though the order was placed on them on 31-05-2019, they started billing from 22-04-2019, which was also unacceptable. In reply to the mails intimating such irregularities, the supplier informed that the above service was continutation of work awarded earlier by C-DIT, for which the subscription services expired on 23-04-2019 and that the P.O in question was for the renewal of that service. The then Registrar, CDIT had placed a purchase order on M/s Sonata Information Technology, Bangalore for availing Services on Customer Engagement Solution - One year subsrciption to Oracle cloud @ Rs.64,73,822/55 inclusive of GST - vide PO No. 034/2019-20 dated 31-05-2019. The order value was payable in advance on quarter-year basis. However, it was seen that purchase formalities and the contractual obligations were not met. There were lapses such as not executing a contract agreement for that purpose nor furnishing bank guarantee by the party. However, the party furnished quarterly invoices for the period from 22-04-2019 to 21-01-2020, claiming use of the cloud solution by CDIT or its clients. Even though the order was placed on them on 31-05-2019, they started billing from 22-04-2019, which was also unacceptable. In reply to the mails intimating such irregularities, the supplier informed that the above service was continutation of work awarded earlier by C-DIT, for which the subscription services expired on 23-04-2019 and that the P.O in question was for the renewal of that service. But there was no reference to any such document in the P.O. under reference.

In this case, EC decided that the cancellation order will prevail for the reasons stated.

2. Suit filed by M/s Kinsfolk Technology Pvt. Ltd., before the Hon'ble Micro and Small Enterprise Facilitation Council, Pune.

Purchase Order No. 127/2018-19 dated 07-11-2018 was issued to M/s Kinsfolk Technology Pvt. Ltd., for supply, instalation and training of IT Service Management helpdesk and Asset Management System at a total cost of Rs. 29.5 lakh inclusive of GST. Out of this, the licence cost of Enterprise Management System Rs 20,36,680/- was already released to the party from Plan funds on receiving the licence code. Implentation cost was Rs. 5,78,200 and AMC charges for one year Rs. 3,23,320/- were not released as the implementation was not completed as per the P.O. However, claiming that 30% of the implementation charges was due to them and that the AMC charges were already paid by them in advance to M/s BMC (The OEM of the software product), they have raised invoices but C-DIT did not release as the terms & codnitions were not met by the party. They filed a suit against C-DIT before the Hon'ble Micro and Small Enterprise Facilitation Council, Pune demanding Rs. 4,96,780/- and interest thereof. The case is still pending.

On seeking report from the Head of the System Integration Dept. they opined that this was sort of perpetual licence but requires AMC support for further implementation and operation. It was also stated that up to 500 assets only could be managed using this software. It was told that the product was originally intended for KSFE project which did not realise. It was also seen that an amount of Rs. 9,71, 994 was spent towards cloud hosting of the solution for testing

3. Purchase Order released to M/s Sinetec Automation Pvt. Ltd

Purchase Order No. 190/2017-18 dated 16-02-2018 was issued to M/s Sinetec Automation Pvt. Ltd., for providing network testing hardware tools at a total cost of Rs. 63.45 lakh inclusive of GST. Another P.O. No. 210/2017-18 dated 23-07-2018 was issued to the same supplier for similar network testing hardware tools at a total cost of Rs. 32.19 lakh inclusive of GST. Both the supplies were unused since then and available in C-DIT stores. It was stated that the procurement was for a large project of KSFE which later got cancelled. However, these hardware tools can be used in similar projects bagged by C-DIT.

4. Purchase Order released to M/s ThoughtRipples

Purchase Order No. 183/18-19 dated 15-02-2019 was issued to M/s ThoughtRipples, for development and deployment of web application and mobile application development for MGNREGA at a total cost of Rs. 19.47 lakh inclusive of GST. Part of amount was released from plan funds and remaining from own funds to the party. However, no gain for C-DIT is seen from this and the purpose of undertaking this work is not clear.

5. Purchase Order released to M/s Nibodha Technologies Pvt. Ltd.

On seeking report from the Head of the System Integration Dept. it was intimated that the components were intended as part of the upgradation of the CMO portal and Kerala Communication Systems (KCS) project which was incomplete and part payment Rs. 825000 was released to the party from Plan funds towards mentoring fee for their efforts but the balance was not released as they could not complete it.

6. Purchase Order released to M/s Expertzlab Technologies Ltd.

Purchase Order No. 143/18-19 dated 03-12-2018 was issued to M/s Expertzlab Technologies Pvt. Ltd., for development and deployment of big data store, analytical engine and exploratory analysis at a total cost of Rs. 28.20 lakh inclusive of GST. Amount was not released to the party and the intended work of CMO/CMDRF data analysis was not taken up as it was allotted to IIITMK by the Govt.

The senior official who were concered with the above procurement have subsequently retired from C-DIT service. Therefore the details above were collected based on the discussions and reports furnished by the respective HoDs of Informatics Division, System Integration Dept and Purchase / Stores Departments and after verfication of the available records / files.
