



ORDER

In compliance with the decision dated.25.02.2021 of the General Body and the Executive Committee decision dated.06.01.2022 and 27.07.2022 sanction was accorded, as per the order read as first paper, for the creation of 87 (eighty seven) posts in different categories in the Society. Since there are no approved recruitment rules in respect of any posts, only entry level posts are created. These 87 posts were created to absorb employees working on temporary basis who have completed 10 years service as on 31.12.2020 to the regular service of the Society.

Accordingly, the employees included in the appendix who have completed minimum period of service of ten years as on 31.12.2020 are hereby absorbed into the regular service of the Society with effect from 01.01.2023.

While regularizing the employees against the posts created, their existing monthly consolidated pay shall be protected. Their pay in the scale of pay of the entry level post will be fixed without any change in the total pay now they are drawing. If the pay presently drawn by the employee is not a stage in the scale of pay of the post to which he is regularised, then his pay will be fixed in the immediate lower stage and the remaining portion of pay will be treated as personal pay. If the existing pay of the employee is lower than the minimum of the scale of pay to which he is regularised, his pay will be fixed at the minimum of the scale of pay. If an employee's existing pay exceeds the maximum of the scale of pay his pay will be fixed at the maximum of the scale of pay and remaining portion of pay will be treated as personal pay.


