ORDER

The Managing Director, Kerala Water Authority as per letters read as first paper above has submitted 753 proposals worth Rs.23505.35 lakhs and 15 proposals worth Rs.629.07 lakhs respectively under various plan heads for according Administrative Sanction.

2. The Department Working Group in its meeting held on 08.06.2018, 28.06.2018 and 04.07.2018, after detailed discussion approved proposals worth Rs,19402.84 lakhs. This includes the additional proposals which were placed before the Department Working Group on 28.06.2018 and 04.07.2018. The list of the additional proposals are attached herewith as Annexure I

3. The Departmental Working Group approved (a) 91 Proposals for replacement of old pipes in existing WSS worth Rs. 8946.13. Lakh as detailed in Annexure II,(b) 45 Proposals for pipeline extension worth Rs.1785.77 lakh, as detailed in Annexure III, (c) 61 proposals for renovation of WTP worth Rs.1581.30 lakh, as detailed in Annexure IV, (d) 119 proposals for energy conservation worth Rs.2435.65 lakh, as detailed in Annexure V, under optimization of production and transmission, under the head of account "4215-01-190-97", with a total out lay of Rs.14748.85 lakh.

4. The Departmental Working Group also approved (e) 50 Proposals for renovation of existing civil structures owned by Kerala Water Authority Worth Rs.546.14 lakh, under the head of account "2215-01-190-92", as detailed in Annexure VI, (f) 12 proposals of Sewerage Schemes of Kerala Water Authority worth Rs.324.91 lakh, under the head of account "4215-02-190-99", as detailed in Annexure VII, (g) 48 proposals of Innovative Technological and Modern Management Practices worth Rs.1437.09 lakh, under the head of account "2215-01-101-97(01)" as detailed in Annexure VIII. (h) 9 proposals of Water Supply Scheme to Specified Institutions / Locations worth Rs.175.56 Lakh under the Head of Account "4215-01-190-98" as detailed in Annexure IX, (i) 15 proposals of source improvement and water conservation worth Rs.428.29 lakh, under the head of Account "4215-01-800-92", as detailed in Annexure X and (j) one proposal of Rural Water Supply Scheme worth Rs.350 lakh under the head of account "4215-01-102-97, as detailed in Annexure XI.

5. The Departmental Working Group also approved (k) proposal for survey and investigation worth Rs.200 lakh under the head of account "2215-01-190-99 (01)", (l) proposal for Human Resources Development Research & Development &Quality Control worth Rs.275 lakh under the head of account "4215-04-190-99" and (m) proposal of ERP, E-Governance, GIS and Information Management Worth Rs.917 lakh, under the head of account "2215-01-190-87".

6. Government have examined the matter in detail and are pleased to accord administrative sanction for Rs. 19402.84 lakh (Rupees One

hundred and Ninety four Crores Two Lakh and Eighty Four Thousand only) for the works as detailed in Annexure II to XI appended to this order and the 3 proposals mentioned at Para 5 above at the estimated costs noted against each proposal subject to the conditions detailed below. The expenditure will be debited under the head of account mentioned against each proposal.

- i. Release of funds will be as per the actual requirements only.
- ii. Funds required for the spillover projects for the next year are to be ensured under the State Plan.
 - iii. Monitoring mechanism has to be formulated for the continuous evaluation and monitoring.
 - iv. It shall be ensured that the estimate is as per the latest SOR.
 - v. The current year's expenditure shall be limited to the budget provision.
 - vi. all the civil works and purchase shall be in compliance with purchase rules and other relevant rules.

7. The administrative sanction will be subject to the following conditions also :-

- i. The TS issuing authority should ensure that there is no duplication of the approved proposals with KIIFB / AMRUT / Deposit works / other centrally sponsored works, etc.
- ii. In all the pipe replacement works and pipeline extension works, the details regarding the existing connections, improvement in the number of

connections, reduction in NRW in terms of the no. of leaks and service quality improvement has to be reported to the Managing Director, at the time of TS and after completion of each work.

- iii. KWA should insist on utilisation certificate from PWD for the amount paid by KWA towards Road Restoration charges.
- iv. While issuing TS for the proposals for installing solar panels, it should be ensured that the installation charges are at par with the prevailing rates.






