O R D E R

The Kerala State Film Development Corporation has sponsored a Society by name "the Centre for Development of Imaging Technology (in short C-DIT) as per the G.O. read above and it was registered under the Societies Registration Act and C-DIT started functioning with effect from 15-12-1988. The main objectives of C-DIT are to establish a modern scientific research and development centre in film and television technology, indigenisation of the hardware needs, production of video-films, training in the use of film and video equipments and organise courses in film, video production techniques and image aesthetics. The Administrative control of C-DIT is vested in a Governing Body consisting of 37 eminent personalities in different fields in the Country.

2. The Registrar, C-DIT vide his letter referred section above has requested for the sanction of a core group initial consisting of Joint Director, Registrar, Deputy Director (Project), Deputy Director (Production), Deputy Director (TAAS) and Scientific Officer (C-DECOM) in order to implement the various projects undertaken by them. He has also reported that the Scale of Pay suggested for the above posts are in conformity with similar posts in CSIR, ISRO etc.

3. After examining the matter in detail, Government are pleased to accord sanction for the creation of a core group for C-DIT with the following posts as detailed below:

According to the principle accepted by Government for the appointments: promotion and grades to vacant posts in the C/DIT having CSIR/UGC Scale of pay and terms and qualifications prescribed by CSIR/UGC are applicable for all posts having state Government employees scale of pay and terms and qualifications fixed for state Government employees are applicable. The above conditions are specified in para 13 of chapter 10 and in para 6 of chapter.

In the above circumstances, the paras 2 of chapter 12 are deleted and substituted with the following.

" (2) For the posts and promotion posts and grades in the ordinary scale of pay and terms and qualifications prescribed by CSIR/UGC are applicable.

(3) For other posts promotion posts and grades having state Government's scale of pay and terms and qualifications fixed by State Government for such posts are applicable."

Add para 6 of chapter 12 also modified accordingly.

ORDER

In the letter read above the Registrar C-DIT has requested Govt. to accord sanction for the pay revision of three posts belonging to the Core Group of C-DIT i.e. the Registrar, Deputy Director (Projects) and Deputy Director (Production). The Registrar has also reported that all the three officers in the Core Group have the requisite qualifications and experience for the posts/grades as prescribed under CSIR/UGC/Central Govt. norms adopted in C-DIT as per the Special Rules approved by the Govt.

Govt. have examined the matter in detail and are pleased to revise the pay of 3 posts belonging to the Core Group of C-DIT i.e. the Registrar, Deputy Director (Projects) and Deputy Director (Production) w.e.f. 1/1/2006 as mentioned below with the following conditions.



- In addition to the proposal for pay revision for 55 employees regularized in C-DIT service submitted as per letter cited, the following 3 employees who were appointed in C-DIT as Permanent Employees in the core group of C-DIT as approved by Government vide G.O.(MS) No.14/90/CAD dated 11.05.1990 is also eligible for pay revision as per CSIR / UGC norms. These three posts are part of the six posts sanctioned by the Government. No incumbents are available in the balance three posts in the core group.

2. In addition to the Central pay revision with effect from 1.1.2006, they are also eligible for 50% DA merger in the pre-revised scale with effect from 1.7.2004 in terms of G.O.(P) No.38/07/(33)/Fin dated 31.01.2007. Since they have been appointed on regular basis with the approval of Government, they are eligible for payment of arrears of pay revision and 50% DA merger in cash.
3. Sri.P.V.Unnikrishnan (Sl.No.1) was posted by the Government in Information Kerala Mission in May 1999 and subsequently appointed on deputation as a Member of State Planning Board since May 2006. Hence the expenditure towards pay revision/arrears in his case will be payable from the IKM/SPB. Sri.G.Jayaraj (Sl.No.2) was appointed by the Government on deputation as Special Private Secretary to Minister for Health & Social Welfare with effect from 1.6.2006. Sri.K.Mohankumar is continuing in C-DIT service. The expenditure towards pay revision and 50% DA merger and payment of arrears in the case of the above employees, other than for the deputation period outside C-DIT service, will be met by C-DIT.
4. In view of above, it is requested that Government may accord approval for implementation of pay revision with effect from 1.1.206 and 50% DA merger w.e.f 1.7.2004 and payment of arrears thereof for the 3 employees also as above.
