#### WHEREAS

- a) The Department having decided to entrust the work "Construction of House Boat Terminal at Thaneermukkom under Development of Backwater Circuit in Alappuzha in Backwater region as a mega circuit in Kerala" in accordance with the Order No 5- PSW(27)/2011 (included as Appendix IV) dated 31/3/2013 of the Ministry of Tourism, Government of India, and the GO (Rt) No 5749/2013/TSM dated 12/7/2013 of Government of Kerala with the Company at a cost of Rs. 162.01 lakhs (Rupees One Hundred and Sixty Two Lakh One Thousand only).
- b) KIIDC having agreed to take up and execute the work.
- c) The parties hereto had detail discussion regarding various aspects of the matter and have reached an understanding which they desire to reduce it to writing.
- d) The work of Construction of House Boat Terminal at Thaneermukkom is not meant predominantly for commerce or business purpose and only an expansion of infrastructure for tourism development.

#### NOW THEREFORE THIS AGREEMENT WITNESSETH AS FOLLOWS:

- I. The Department hereby agrees to engage KIIDC to take and execute the work "Development of Backwater Circuit in Alappuzha-House Boat Terminal at Thaneermukkom".
- II. KIIDC hereby agrees and undertakes to perform all the services, duties and responsibilities in the execution of the work which are more specifically described in Appendix I and II attached to this Agreement.

#### SCOPE AND RESPONSIBILITIES

#### Part I

### a. Preliminary works

KIIDC shall prepare detailed estimate for the work "Construction of House Boat Terminal at Thaneermukkom under Development of Backwater Circuit in Alappuzha in Backwater region as a mega circuit in Kerala". Technical Sanction

KIIDC shall issue technical sanction for the work "Construction of House Boat Terminal at Thaneermukkom under Development of Backwater Circuit in Alappuzha in Backwater region as a mega circuit in Kerala".

#### Preparation of tender documents and tendering

The tender documents shall be prepared for inviting bids, after incorporating chapters such as general conditions, special conditions, technical specifications, schedule of quantities, tender purpose drawings, etc. All services required for releasing of advertisement in this connection shall be carried out by KIIDC, but the actual advertisement charges will be to the account of the Department of Tourism. E-tender system shall be followed for the tendering of works.

## b. Tender Evaluation and Contracting

Evaluation of technical, commercial, financial aspects of the tenders received, seeking clarification, if any, required and ensuring that the bids received are in compliance to the tender specifications and submission of recommendation for selection of tenders. On approval, KIIDC will execute an agreement with the selected tenderer.

- A detailed time schedule for the completion of various items of work will be drafted by KIIDC in consultation with the Contractor within the time frame prescribed in the contract agreement. KIIDC shall keep a close watch to ensure that the approved time schedule is strictly followed.
- KIIDC will get the work executed as per approved plans, specifications and as per terms and conditions of the agreement executed with the Contractor by rendering total and complete supervision of the work.
- 3. As directed by Government, for day to day supervision and inspection and such other services as may be necessary to ensure that the works are being carried out in accordance with the contract, the works will be executed under the supervision of KIIDC.
- KIDC shall advise the Department on the progress of the work and furnish monthly progress reports.
- KIIDC shall take all necessary measures to ensure quality of work and to keep a watch on the usage of steel, cement, etc. as per approved specifications.
- 6. KIIDC shall advice the Department on expenditure and cost control and in case the expenditure on any item is likely to exceed, the KIIDC shall give a report to the Department sufficiently early before incurring any excess expenditure.

 KIIDC shall also inform sufficiently in advance in case the period of construction is likely to be varied and shall render necessary advice on it.

 KIIDC shall carry out joint measurements along with the Contractor and shall verify, approve, certify bills submitted by the Contractor and release payment from the deposit amount.

 KIIDC shall duly certified for accuracy and correctness of the works executed with Department after obtaining the written acceptance of the Contractor at the time of the final bill.

10. KIIDC shall furnish such information to the Department and advice regarding fulfilment of Contractor's obligations in respect of the contract such as reports, progress, charts etc.

11. KIIDC shall arrange to conduct the required tests for ascertaining the quality of the construction materials and work and instruct the Contractor for the removal of materials or work which does not satisfy specified quality and replacement of the same with materials or work as per relevant specifications of BIS. KIIDC shall enforce specifications of BIS wherever they are applicable in the work.

12. KIIDC shall ensure that a clause stipulating timely completion of the project by the Contractor will be included in the agreement with the Contractor.

Based on the site conditions detailed estimate and schedule of quantities will be prepared by KIIDC. One set of estimate will be supplied to the Department.

#### **GENERAL**

- 1. KIIDC will assist the Department in applying for, following up and procuring the required statutory clearances from the authorities concerned by supplying all the necessary technical data required for the completion of formalities connected with the obtaining of the statutory clearance and furnishing clarifications wherever necessary. However obtaining such statutory clearances shall be Department's responsibility
- Changes in the scope of work shall be worked out by mutual consultation between the Department and KIIDC, provided that all such changes in the scope of work shall be reduced in writing and approved by the parties, along with the terms and conditions agreed upon.
- 3. Any expenses incurred for outstation tours undertaken by the officers of the KIIDC, in connection with the works shall be paid for by the Department in accordance with the provisions in the prevailing staff rules of the KIIDC provided that the tour is undertaken on specific request by the Department.

## RESPONSIBILITIES OF THE DEPARTMENT

The Department shall perform all obligations required of it, as owner in order to enable KIIDC to successfully perform its obligation under this contract. Obligations of the Department shall generally be as follows.

 The project shall be entrusted with KIIDC as a deposit work on cost plus execution fee basis. The Department shall deposit up to 80% of

the estimated cost of each work with a minimum of 50% as advance with KIIDC. Balance 30% will be paid depending on the progress of the work. Thereafter all the expenditure of the project shall- be paid by KIIDC from the deposit amount. The final 20% will be transferred by the Department to KIIDC account on completion of the work before settling the final payment of the Contractors. KIIDC's fee shall be withdrawn from the deposit amount.

- The Department shall provide necessary data regarding the operational parameters required to be incorporated in the design of buildings to the Consultant in proper time to enable them to proceed with the design to meet the time schedule.
- 3. The Department shall review and approve or communicate their comments on technical documents such as estimates and specifications submitted by KIIDC for this purpose, as early as possible, on receipt from KIIDC. Review of documents, if found necessary, shall be conducted in a design conference to be convened by KIIDC at a time and venue as mutually agreed upon from time to time.

4. The Department shall make available adequate land with properly demarcated boundaries, free from any legal restrictions before the

commencement of the work.

#### **DEFINITIONS** 1.0

#### **GENERAL** 2.0

KIIDC shall render the services as listed separately in Appendix- 1. The Department shall be fully associated at every stage of the construction and KIIDC shall take into account any suggestion/comments given by the Department in this regard.

#### 3.0 **ARBITRATION**

All disputes or differences whatsoever arising between the parties out of or

relating to the construction, interpretation and operation or effect of any of the terms in this agreement or the breach thereof and all claims and benefits which arise out of the contract, but which are disputed, shall be

2. The sanction of the President is however accorded for release of Rs 2,38,12,400/- (Rupees two crore thirty eight lakh twelve thousand four hundred only) (being 05% of the sanctioned CFA) as first installment of the Central Financial Assistance as an advance for starting the work. Out of the

Managing Director Kerala Irrigation Infrastructure Development Corporation Ltd. first instalment Rs. 1.04 Crore (Rs. One crore four lakh only) is being released due to non availability of sufficient funds. Since no funds were released for this project earlier, no utilization certificate is due in the matter.

- 3. The State Government of Kerala shall make land for the project available free of cost and also render all possible assistance for completion of the project in time. No portion of the sanctioned project should be executed/implemented in land/property owned by private individual or trust.
- The Principal Secretary (Tourism), Government of Kerala will be the nodal officer for implementation and monitoring of the project. The State Government of Kerala shall set up a Monitoring Committee headed by the Principal Secretary (Tourism) with a Member from the Ministry of Tourism and the Implementing agency to monitor physical and financial progress of the sanctioned project and submit the progress report to Ministry of Tourism on quarterly basis in the format enclosed with this order.
- The executing agency shall put in place the mandatory facilities for barrier free access by physically disabled persons.
- 6. The State Government of Kerala would get the work executed through the Department of Tourism, Government of Kerala and shall have the work started immediately to ensure timely utilization of funds and to avoid escalation of cost. The project should be commissioned within 36 months. No reimbursement will be made by the Central Government on this account. The components which are not being funded by CFA and also future cost escalation, if any, would be borne by the State Government/concerned agency to complete the project in time. No reimbursement will be made by the Central Government on this account.
- 7. The Central Financial Assistance will be utilized for the purpose for which the funds are released.
- 8. The State Government of Kerala would undertake the responsibility for maintenance and management of facilities for which the funds are released and no reimbursement on account of losses incurred, if any, would be made by the Central Government.
- The State Government of Kerala would take all necessary clearances which are required as per prevailing rules and regulations before undertaking this project.
- 10. The State Government of Kerala would obtain all necessary clearances from the Forest and Environment angle before implementation of the project.
- 11. Further funds would be released after receipt of utilization certificate.
- 12. The State Government will furnish an undertaking for not selling, leasing or alienating the assets created in any way without the prior permission of Ministry of Tourism.
- 13. The State Government of Kerala will not keep the amount released by Central Government unutilized for more than six months. In case the funds cannot be utilized by such time the same will have to be surrendered to Central Government with interest or their formal approval should be taken to transfer/adjust the amount against other Central financially assisted projects.

Principal Accounts Officer is requested to advise RBI for the payment of Rs 1.04 Crore (Rs. One crore four lakh only) to the Government of Kerala.

- 17. The State Government of Kerala would obtain all necessary clearances from the Forest and Environment angle and CRZ clearance before implementation of the project.
- 18. The assets acquired wholly or substantially out of CFA except those declared as obsolete and unserviceable or condemned in accordance with the procedure laid down in GFR shall not be disposed of without obtaining the prior approval of the authority which sanctioned the Central Financial Assistance.
- 19. It is certified that no utilization certificate is pending from the State Government of Kerala in respect of grant in aid released by the Central Government in respect of all the schemes / projects/programmes of Ministry of Tourism.
- 20. The expenditure involved is debitable to Demand No.94-Tourism, 3601-Grants-in-aid to State Governments 04-Grants for Centrally Sponsored Plan Scheme(Sub Major Head), 826-Tourist Infrastructure-Tourist accommodation(Minor Head), 01-Product/Infrastructure Development for Destination and Circuits, 01-00-35- Grants for creation of Capital assets for the year 2012-13(Plan) (3601.04.826.01.00.35).

# NOW THEREFORE THIS AGREEMENT WITNESSETH AS FOLLOWS:

- The Department hereby agrees to engage KIIDC to take and execute the work "Construction of House Boat Terminal at Kanjipadam under Development of Backwater Circuit in Alappuzha in Backwater region as a mega circuit in Kerala".
- II. KIIDC hereby agrees and undertakes to perform all the services, duties and responsibilities in the execution of the work which are more specifically described in Appendix – I and II attached to this Agreement.

## SCOPE AND RESPONSIBILITIES

#### Part I

### a. Preliminary works

KIIDC shall prepare detailed estimate for the work "Construction of House Boat Terminal at Kanjipadam under Development of Backwater Circuit in Alappuzha in Backwater region as a mega circuit in Kerala".

#### **Technical Sanction**

KIIDC shall issue technical sanction for the work "Construction of House Boat Terminal at Kanjipadam under Development of Backwater Circuit in Alappuzha in Backwater region as a mega circuit in Kerala".

## Preparation of tender documents and tendering

The tender documents shall be prepared for inviting bids, after incorporating chapters such as general conditions, special conditions, technical specifications, schedule of quantities, tender purpose drawings, etc. All services required for releasing of advertisement in this connection shall be carried out by KIIDC, but the actual advertisement charges will be to the account of the Department of Tourism. E-tender system shall be followed for the tendering of works.

## b. Tender Evaluation and Contracting

Evaluation of technical, commercial, financial aspects of the tenders received, seeking clarification, if any, required and ensuring that the bids received are in compliance to the tender specifications and submission of recommendation for selection of tenders. On approval, KIIDC will execute an agreement with the selected tenderer.

## c. Project Management Services

 A detailed time schedule for the completion of various items of work will be drafted by KIIDC in consultation with the Contractor within the

time frame prescribed in the contract agreement. KIIDC shall keep a close watch to ensure that the approved time schedule is strictly followed.

KIIDC will get the work executed as per approved plans, specifications and as per terms and conditions of the agreement executed with the Contractor by rendering total and complete supervision of the work.

3. As directed by Government, for day to day supervision and inspection and such other services as may be necessary to ensure that the works are being carried out in accordance with the contract, the works will be executed under the supervision of KIIDC.

 KIDC shall advise the Department on the progress of the work and furnish monthly progress reports.

KIIDC shall take all necessary measures to ensure quality of work and to keep a watch on the usage of steel, cement, etc. as per approved specifications.

6. KIIDC shall advice the Department on expenditure and cost control and in case the expenditure on any item is likely to exceed, the KIIDC shall give a report to the Department sufficiently early before incurring any excess expenditure.

- 8. KIIDC shall carry out joint measurements along with the Contractor and shall verify, approve, certify bills submitted by the Contractor and release payment from the deposit amount.
- 9. KIIDC shall duly certified for accuracy and correctness of the works executed with Department after obtaining the written acceptance of the Contractor at the time of the final bill.
- 10. KIIDC shall furnish such information to the Department and advice regarding fulfilment of Contractor's obligations in respect of the contract such as reports, progress, charts etc.
- 11. KIIDC shall arrange to conduct the required tests for ascertaining the quality of the construction materials and work and instruct the Contractor for the removal of materials or work which does not satisfy specified quality and replacement of the same with materials or work as per relevant specifications of BIS. KIIDC shall enforce specifications of BIS wherever they are applicable in the work.
- 12. KIIDC shall ensure that a clause stipulating timely completion of the project by the Contractor will be included in the agreement with the Contractor.

#### **GENERAL**

- 1. KIIDC will assist the Department in applying for, following up and procuring the required statutory clearances from the authorities concerned by supplying all the necessary technical data required for the completion of formalities connected with the obtaining of the statutory clearance and furnishing clarifications wherever necessary. However obtaining such statutory clearances shall be the Department's responsibility
- Changes in the scope of work shall be worked out by mutual consultation between the Department and KIIDC, provided that all such changes in the scope of work shall be reduced in writing and approved by the parties, along with the terms and conditions agreed upon.
- 3. Any expenses incurred for outstation tours undertaken by the officers of the KIIDC, in connection with the works shall be paid for by the Department in accordance with the provisions in the prevailing staff rules of the KIIDC provided that the tour is undertaken on specific request by the Department.

#### RESPONSIBILITIES OF THE DEPARTMENT

The Department shall perform all obligations required of it, as owner in order to enable KIIDC to successfully perform its obligation under this contract. Obligations of the Department shall generally be as follows.

1. The project shall be entrusted with KIIDC as a deposit work on cost plus execution fee basis. The Department shall deposit up to 80% of the estimated cost of each work with a minimum of 50% as advance with KIIDC. Balance 30% will be paid depending on the progress of the work. Thereafter all the expenditure of the project shall- be paid by KIIDC from the deposit amount. The final 20% will be transferred

- The Department shall provide necessary data regarding the operational parameters required to be incorporated in the design of buildings to the Consultant in proper time to enable them to proceed with the design to meet the time schedule.
- 3. The Department shall review and approve or communicate their comments on technical documents such as estimates and specifications submitted by KIIDC for this purpose, as early as possible, on receipt from KIIDC. Review of documents, if found necessary, shall be conducted in a design conference to be convened by KIIDC at a time and venue as mutually agreed upon from time to time.
- The Department shall make available adequate land with properly demarcated boundaries, free from any legal restrictions before the commencement of the work.

2. The sanction of the President is however accorded for release of Rs 2,38,12,400/- (Rupees two crore thirty eight lakh twelve thousand four hundred only) (being 05% of the sanctioned CFA) as first installment of the Central Financial Assistance as an advance for starting the work. Out of the

first instalment Rs. 1.04 Crore (Rs. One crore four lakh only) is being released due to non availability of sufficient funds. Since no funds were released for this project earlier, no utilization certificate is due in the matter.

- 3. The State Government of Kerala shall make land for the project available free of cost and also render all possible assistance for completion of the project in time. No portion of the sanctioned project should be executed/implemented in land/property owned by private individual or trust.
- The Principal Secretary (Tourism), Government of Kerala will be the nodal officer for implementation and monitoring of the project. The State Government of Kerala shall set up a Monitoring Committee headed by the Principal Secretary (Tourism) with a Member from the Ministry of Tourism and the Implementing agency to monitor physical and financial progress of the sanctioned project and submit the progress report to Ministry of Tourism on quarterly basis in the format enclosed with this order.
- 5. The executing agency shall put in place the mandatory facilities for barrier free access by physically disabled persons.
- 6. The State Government of Kerala would get the work executed through the Department of Tourism, Government of Kerala and shall have the work started immediately to ensure timely utilization of funds and to avoid escalation of cost. The project should be commissioned within 36 months. No reimbursement will be made by the Central Government on this account. The components which are not being funded by CFA and also future cost escalation, if any, would be borne by the State Government/concerned agency to complete the project in time. No reimbursement will be made by the Central Government on this account.
- 7. The Central Financial Assistance will be utilized for the purpose for which the funds are released.
- 8. The State Government of Kerala would undertake the responsibility for maintenance and management of facilities for which the funds are released and no reimbursement on account of losses incurred, if any, would be made by the Central Government.
- The State Government of Kerala would take all necessary clearances which are required as per prevailing rules and regulations before undertaking this project.

- 11. Further funds would be released after receipt of utilization certificate.



2. The sanction of the President is however accorded for release of Rs 2,38,12,400/- (Rupees two crore thirty eight lakh twelve thousand four hundred only) (being 05% of the sanctioned CFA) as first installment of the Central Financial Assistance as an advance for starting the work. Out of the


2. The sanction of the President is however accorded for release of Rs 2,38,12,400/- (Rupees two crore thirty eight lakh twelve thousand four hundred only) (being 05% of the sanctioned CFA) as first installment of the Central Financial Assistance as an advance for starting the work. Out of the

Managing Director Kerala Irrigation incastructure Development Corporation Etd. Vasanth Vihar Gardens first instalment Rs. 1.04 Crore (Rs. One crore four lakh only) is being released due to non availability of sufficient funds. Since no funds were released for this project earlier, no utilization certificate is due in the matter.

- 3. The State Government of Kerala shall make land for the project available free of cost and also render all possible assistance for completion of the project in time. No portion of the sanctioned project should be executed/implemented in land/property owned by private individual or trust.
- The Principal Secretary (Tourism), Gevernment of Kerala will be the nodal officer for implementation and monitoring of the project. The State Government of Kerala shall set up a Monitoring Committee headed by the Principal Secretary (Tourism) with a Member from the Ministry. Monitoring Committee headed by the Principal Secretary (Tourism) with a Member from the Ministry of Tourism and the Implementing agency to monitor physical and financial progress of the sanctioned project and submit the progress report to Ministry of Tourism on quarterly basis in the format enclosed with this order.
- 5. The executing agency shall put in place the mandatory facilities for barrier free access by physically disabled persons.
- 6. The State Government of Kerala would get the work executed through the Department of Tourism, Government of Kerala and shall have the work started immediately to ensure timely utilization of funds and to avoid escalation of cost. The project should be commissioned within 36 months. No reimbursement will be made by the Central Government on this account. The components which are not being funded by CFA and also future cost escalation, if any, would be borne by the State Government/concerned agency to complete the project in time. No reimbursement will be made by the Central Government on this account.
- 7. The Central Financial Assistance will be utilized for the purpose for which the funds are released.
- 8. The State Government of Kerala would undertake the responsibility for maintenance and management of facilities for which the funds are released and no reimbursement on account of losses incurred, if any, would be made by the Central Government.
- The State Government of Kerala would take all necessary clearances which are required as per prevailing rules and regulations before undertaking this project.
- 10. The State Government of Kerala would obtain all necessary clearances from the Forest and Environment angle before implementation of the project.
- 11. Further funds would be released after receipt of utilization certificate.
- 12. The State Government will furnish an undertaking for not selling, leasing or alienating the assets created in any way without the prior permission of Ministry of Tourism.
- 13. The State Government of Kerala will not keep the amount released by Central Government unutilized for more than six months. In case the funds cannot be utilized by such time the same will have to be surrendered to Central Government with interest or their formal approval should be taken to transfer/adjust the amount against other Central financially assisted projects.
- 14. Principal Accounts Officer is requested to advise RBI for the payment of Rs 1.04 Crore (Rs. One crore four lakh only) to the Government of Kerala.
