(AMENDMENT) BILL, 2022

(Report of the Subject Committee)

Subject Committee I (Agriculture, Animal Husbandry and Fisheries) to which “The Kerala Veterinary and Animal Sciences University (Amendment) Bill, 2022” was referred, considered the Bill (Bill No. 140) clause by clause and now submits this report with the Bill as reported by the Subject Committee annexed thereto.

2. The Kerala Veterinary and Animal Sciences University (Amendment) Bill, 2022 was published as a Gazette Extraordinary dated 26th September, 2022. The Bill was introduced in the Assembly on 5th December, 2022 and was referred to the Subject Committee on the same day.

3. The Committee considered the Bill clause by clause at its meeting held on 5th December, 2022 and recommends to adopt the Bill without modifications.

4. All other changes are either verbal or consequential.

5. The Minutes of dissent and the Bill as reported by the Subject Committee are appended.

### വിയോജനക്കുറിപ്പ്

സംസ്ഥാനത്തെ സർവ്വകലാശാലകളിലെ അധ്യാപക-അധ്യാപകേതര തസ്തികകളിലേക്കുള്ള നിയമനങ്ങളിൽ സംവരണവും സാമുദായിക ക്രമവും സംബന്ധിച്ച് ഏകീകൃത വ്യവസ്ഥ കൊണ്ടുവരുന്നതിനായി 2010 -ലെ കേരള വെറ്ററിനറിയും ജന്തുശാസ്ത്രങ്ങളും സർവ്വകലാശാല ആക്റ്റിന്റെ വകുപ്പ് 58 ഭേദഗതി ചെയ്യുന്നതിനാണ് ബില്ലിൽ വ്യവസ്ഥ ചെയ്തിട്ടുള്ളത്.

സർവ്വകലാശാല നിയമനങ്ങളിൽ സംവരണവ്യവസ്ഥകൾ ഏകീകരിക്കുന്നതിനായി നിയമനിർമ്മാണം നടത്തുന്നതിനോട് യോജിക്കുന്നു. എന്നാൽ സർവ്വകലാശാലകളിലെ നിയമനങ്ങളിൽ യു.ജി.സി. മാനദണ്ഡങ്ങൾക്ക് വിരുദ്ധമായി നടപടി സ്വീകരിക്കുന്നതിലൂടെയും ബന്ധു നിയമനങ്ങളിലൂടെയും ഉന്നത വിദ്യാഭ്യാസ മേഖലയിൽ പ്രതിസന്ധികൾ സൃഷ്ടിക്കുന്ന നയങ്ങൾ പിന്തുടരുന്നതിനാൽ ബില്ലിനോട് വിയോജിക്കുന്നു.

APPENDIX II

THE KERALA VETERINARY AND ANIMAL SCIENCES  
UNIVERSITY ( AMENDMENT) BILL, 2022  
(As reported by the Subject Committee)

*BILL*

*further to amend the Kerala Veterinary and Animal Sciences University Act, 2010.*

*Preamble.*—WHEREAS, it is expedient further to amend the Kerala Veterinary and Animal Sciences University Act, 2010 (Act 3 of 2011) for the purposes hereinafter appearing;

BE it enacted in the Seventy-third Year of the Republic of India as follows:—

1. *Short title and commencement.*—(1) This Act may be called the Kerala Veterinary and Animal Sciences University (Amendment) Act, 2022.

(2) It shall come into force at once.

2. *Substitution of new section for section 58.*—In the Kerala Veterinary and Animal Sciences University Act, 2010 (Act 3 of 2011), for section 58, the following section shall be substituted, namely:—

“58. *Reservation of appointments.*—In making appointments to the teaching and non-teaching posts, the University shall, *mutatis-mutandis*, observe the provisions of clauses (a), (b) and (c) of rule 14 and the provisions of rules 15,16,17 and 17A of the Kerala State and Subordinate Services Rules, 1958, as amended from time to time, and communal rotation shall be followed category-wise treating all the departments as one unit.”.
