- 2) The Chief Engineer has reported that Kerala coast had suffered severe sea attack in the previous years during the monsoon season. The South West monsoon is expected to commence by 1 st June 2021. If the funds are received in time, the materials could be stocked and the works could be taken up as and when the necessity arises. The required materials are Geobags, Sand for filling Geo-bags and Rubble. It is also proposed that, as an initial step, materials required for protection works using Geo-bags for 300m and using rubble for 265m need be stocked in each coastal district to meet the emergency situations. 
