



1.0. Introduction:

District Tourism Promotion Council (DTPC) is an organization under the State government that mainly focuses on the promotion of tourism through public and private participation, improving the infrastructure and standard of tourist places and products by ameliorating the sanitation facilities and marketing of local products.

1.1 Objectives:

To the vision of the government in promoting adventure destinations DTPC propose to create a new glass bridge at Akkulam the first of kind in any public park in state.

Nestled within the picturesque ambiance of Akkulam, this proposed glass bridge is set to offer an unparalleled vantage point for visitors. Walking upon this transparent marvel will provide a unique perspective, allowing individuals to marvel at the natural beauty beneath their feet while also experiencing a rush of excitement and wonder. This pioneering initiative captures the essence of adventure by seamlessly integrating thrill with the tranquility of nature.

1.2 How to apply:

Agencies willing to apply must download the tender notification containing the application form online from our website: www.dtpcthiruvananthapuram.com/tenders.

Only those agencies meeting the prequalification criteria need to apply. QCBS or Quality & Cost based selection method is followed where applicant must submit 2 bids: 1) Technical bid for project quality assessment and second cover with financial bid. To know the facility you are bidding for you may visit the location and submit proposal accordingly.

Tender Fee INR 1000/- for application and an EMD of INR 10,000/-

Important Dates:

Last Application Date: 16th August 2023, 4 pm.

1.3 Selection Procedure:

The procedure for the selection of agencies will be done by a committee constituted by the Chairman & District Collector.

1. Pre-Qualification Process:

Only those agencies that satisfy the Pre-Qualification Criteria (PQC) in areas mentioned in the project will be considered and rest will be rejected with no refund of form fee.

(b) Site Visit:

The agencies invited for Pre Bid Meeting will be provided with the brief for the strategy and creative presentation. The agencies will be given a notice period of minimum two weeks from the date of Pre- bid meeting, for submission of Technical & Financial Bids and to do the Creative/Strategy Presentation.

- (c) **Earnest Money Deposit:** The agencies should deposit an Earnest Money Deposit (EMD) of Rs.10,000/- (Ten Thousand only) online to the account of District Tourism Promotion Council, Thiruvananthapuram along with the submission of Technical & Financial Bids, on the following conditions.
- i. Bids not accompanied by the EMD will be rejected.
- ii. EMD will be refunded not later than 120 days from bid due date, without any interest, except in case of the 3 highest-ranked bidders. EMD of the 2nd & 3rd ranked bidders shall be refunded on signing of the agreement with the selected bidder. The selected bidder's EMD shall be returned upon completion of the process of selection.
- iii. The EMD will be forfeited, if the applicant fails to abide by the conditions laid down in this RFP document or any other reasons significant in this process.

(d) Bidding Process:

DTPC has adopted a Two-Stage, bidding process (collectively referred to as the "Bidding Process") for selection of the agencies. The first stage of the evaluation referred to as "Technical Bid" and the second as "Financial Bid".

Both the Technical (Cover 1) & financial Bids(Cover 2) should be submitted in a sealed envelope to District Tourism Promotion Council Thiruvananthapuram administrative office at Vellayambalam.

- Technical Bid: The Technical Bids will be opened by the evaluation committee and marks will be given based on the criteria detailed in the technical bid document and project presentation. The Technical Marks obtained will be referred to as Technical Scores (St). Agencies will be ranked on the basis of the Technical Score (St), and only agencies who have scored 50 or more marks out of 100 marks, will be qualified for financial evaluation. The list of technically qualified applicants will be published in the website of DTPC on the date shown in the schedule of process/informed by the department.
- Financial Bid: The Financial Bids of the agencies that have scored 50 or more in Technical Score (St) will be opened on the date shown in the schedule of process/informed by the department. The highest Financial Proposal (Fm) will be given a Financial Score (Sf) of 100 points. The financial scores of the other Financial Proposals will be determined using the following formula:

Sf = F/Fm * 100

in which Sf is the Financial Score, F is the financial proposal under consideration and Fm is the highest Financial bid submitted.

Combined Technical and Financial Score

For final evaluation, the Agencies will be ranked in accordance with their combined Technical (St) and Financial (Sf) scores with weight age. Since tourism destination marketing requires domain knowledge with creative competence, the Technical Score (St) will be given 80% weightage and Financial Score (Sf) will be given 20% weightage, so that the combined Score will be:

S = St x Tw + Sf x Fw;

Where S is the Combined Score, and Tw and Fw are weights assigned to Technical Score and Financial Score respectively, ie 0.80:0.20.

1.4 Selection of the Agency:

The Agency with highest Combined Technical & financial Score (S) will be selected, ased on the above QCBS system. In the event of two or more agencies obtaining the same highest Combined Technical & financial Score (S), the agency with maximum technical score will be selected.

Selected agency will be notified by selection letter and agreement will be entered for a period of 5 years by DTPC and extendable to a tenure of maximum tenure of 10 years but with annual inspection report being above satisfactory in terms of operations, maintenance and also considering revenue contribution to the council.

Security Deposit: The successful bidder will have to deposit a security deposit for an amount 6 times the financial bid in total of maximum 2 lakhs (which ever is higher)or provide a bank guarantee in equal to the said amount. The security deposit will be retained for the period of agreement and refunded upon termination of this agreement within a period of 3 months.

Construction Phase: Structure built will be safety audited by a committee comprising engineers and given noc to operate. The selected bidder is liable to ensure safety of the structure built.

1.5 Schedule of selection process:

- Last date of application: 16th August, 2023
- Presentation within 1 week of the application & technical score publishing.
- Top 3 scores invited to open financial bid.
- Awarding of bid basis the total combined score.(Technical & Financial bid)

1.6 General Terms & Conditions:

 The bidder is expected to examine all the instructions, guidelines, terms and conditions. Failure to furnish all the necessary information as required by the tender document or submission of a proposal not substantially responsive to all the aspects of the tender conditions shall be at bidder's own risk and may be liable for rejection.

• Initially, the lease/contract will be for a period of 5 year commencing from the date of signing of agreement. The successful bidder is expected to complete work on investment projects with written request to DTPC and consent from secretary. Any projects to build and ready the destination for operations. Such a period will not operation viz. signing of agreement.

• There will be an annual inspection of the leased space or whatever components covered in the project by the secretary or an authority appointed by the secretary as per directions of the District collector or Chairman, DTPC or by officials of department of Tourism. Upon satisfactory report of proper maintenance of property and operations the contracts stand renewed meeting other conditions of contract agency stating the reason and cancelling agreement shall be at its sole discretion.

After the 5-year period, the contract can be continued for a period to a maximum of 5 years (considering larger investment projects and satisfactory operations of the successful bidder). This renewal is not a right of the operator; however, such renewal is on a satisfactory completion of the previous 5-year period. Such renewal is up to a maximum period of 10 years. After that, the contract will not be continued, unless otherwise decided by the DTPC Thiruvananthapuram on an exemplary performance by the successful bidder combine with audited report of investments done by the Chairman of DTPC, Executive committee of DTPC and permission from department of tourism.

• GST at the prevailing rates will be applicable to the annual lease amount. On acceptance of the bid the qualified bidder and DTPC Thiruvananthapuram shall promptly and in no event later than 7 days from the date of acknowledgement of the letter of acceptance the bidder should execute an agreement, register the same at his cost and has to remit an amount equivalent to six months lease amount as security deposit. This security deposit will be returned after a three months period from the date of termination of the contract after clearing all the liabilities due to DTPC Thiruvananthapuram. Security deposit remitted will not carry any interest.

1.7 Risk - Clause: If the agency, after entering in to the Service Agreement with the DTPC TVM, fails to abide by the Terms and Conditions of the RFP document or fails to operate within the specified time or at any time repudiates the contract,

DTPC will have the right to:

Forfeit the EMD/Performance Security.

Before 01 months of completion date of contract the agency must give in writing
its willingness to continue contract upon satisfactory inspection report of its
performance in terms of accomplishing the project submitted for bidding this
project.

1.8 Arbitration

- In the event of any question, dispute or difference arising under this agreement or
 in connection therewith (except as to the matters, the decision to which is
 specifically provided under this agreement), the same shall be referred to the sole
 arbitration of the Secretary District Tourism Promotion Council,
 Thiruvananthapuram.
- The arbitrator may from time to time with the consent of both the parties enlarge the time frame for making and publishing the award. Subject to the aforesaid, Arbitration and Conciliation Act,1996 and the rules made there under, any modification thereof for the time being in force shall be deemed to apply to the arbitration proceeding under this clause.
- The venue of the arbitration proceeding shall be the office of Secretary, District Tourism Promotion Council or such other places as the arbitrator may decide.
