### **REPORT**

This Report deals with the Action Taken by the Government on the recommendations contained in the Seventy Third Report of the Committee on Public Undertakings (2004-06) relating to Kerala Small Industries Development Corporation Limited based on the Report of the Comptroller and Auditor General of India for the year ended 31st March, 1998 (Commercial) which was presented to the House on 24th March, 1999.

The Report contained only one recommendation; Government have furnished reply to that recommendation. The Committee on Public Undertakings (2011-14) considered the reply received from Government at its meeting held on 5th December, 2012.

The Committee accepted the reply to the recommendation 1(2) with remark. This recommendation, its reply and the remark form Chapter I of the Report.

1	2	Industries	The Committee concludes that the Board had specifically violated the rules while taking up the project of the construction of a commercial complex at Kochi on an estimated cost of ₹ 20.37 crore, without obtaining proper sanction from Government. The Committee cannot understand the rationale behind this hasty action as the aim of Kerala Small Industries Development Corporation Ltd., is solely to encourage the setting up of Small Industries in the State, and not building commercial complexes. Moreover, the accumulated loss of the company up to 1993-94 was ₹ 9.09 crore and the Company would have to depend on borrowed funds to meet the expenses of the project. There was really no need to take up such a huge project and that too before obtaining Government sanction. The Committee expresses displeasure over	The matter was examined by Government in detail and direction was given to the Managing Director, SIDCO to take Revenue Recovery steps through the Revenue Authorities for recovery of the loss sustained to SIDCO amounting ₹ 7.49 lakh from the then Managing Director, Shri R. Harikumar and M. Damodaran as per Government Letter No. 24681/F2/2004/Ind. dated 3-12-2011.
