REPORT

The Report deals with the Action Taken by Government on the recommendations contained in the Sixty First Report of the Committee on Public Undertakings (2008-11) relating to the State Farming Corporation of Kerala Limited based on the Report of the Comptroller and Auditor General of India for the years ended 31st March, 2003 and 31st March, 2004 (Commercial) which were presented to the House on 25th February, 2009.

The Report contained 2 recommendations and the Government furnished replies to those recommendations. The Committee (2011-14) considered the replies received from Government at its meeting held on 11th January, 2012. The Committee accepted the reply to the recommendation No. 1(4) without any remarks. This recommendation and its reply furnished by Government form Chapter I of the Report.

The Committee accepted the reply to the recommendation No. 2(10) with remarks. This recommendation, its reply furnished by Government and the remarks of the Committee, form Chapter II of the Report.

reported satisfactory performance of the machine as a result of which the Company released the balance payment of ₹ 5.36 lakh to the supplier in January 1999. Further even though the Company could demand that the supplier take back the faulty machine at his risk and cost within the warranty period of one year as per clause 10 of the agreement made with the supplier, the company reported the poor performance of the machine to the supplier only in November, 1999 i.e. after expiry of the warranty period in October 1999. The Committee views this seriously and concludes that this is a clear case of malpractice. The Committee is surprised that Government has not taken any action in the matter though it was pointed out by Audit

b 0 d S relating to the purchase centrifuging machine. The Corporation have filed a case against M/s India Centrifuges (P) Limited, the supplier, to recover the loss incurred due to the malfunctioning, continuous breakdown and consequent discarding machine. The case is pending before the Court.
