Announcement by Speaker

On December 18, 1997 the Speaker informed the House that subject to the conditions stipulated in the order of stay passed by the Supreme Court, Shri Thampoor Ravi will continue as a member of the Assembly (The High Court of Kerala had declared the election of Shri Thampoor Ravi as void as per the common judgement dated 29-9-1997 in E. P. 15/96 and 16/96 and the resocial of membership had come into force from 11-11-1997).

Motion for extension of time

On December 9, 1997 Shri E. Chandrasekharan Nair, Minister for Food, Tourism and Law moved that the time for Presentation of Report of the Subject Committee on the Kerala Ration Dealers' Welfare Fund Bill, 1997 be extended till December 9, 1997 and the same was adopted by the House.

Question of Breach of Privilege

3. Notice given by Shri K. C. Joseph against Shri E. K. Nayanar, Chief Minister based on a statement he made in the Press Conference held on 11th September, 1997, in connection with the Alappuzha South Police Station incident in which Shri K. C. Venugopal was allegedly assaulted by the Police Officers on 7-9-1997.

4. Notice given by Shri K. A. Chandran against the Officers, who were allegedly responsible for registering a case against Shri Mamman Mathai who allegedly interfered in a spurious liquor case at Thiruvalla.

5. Notice given by Shri K. T. Kunhahammed against the Editor, Printer and Publisher of the "Mangalam" Daily for the publication of a news item under the caption "മന്ത്രി മുൻമതി, എൽ.എൽ. റാഡ്രേഷൻ."

Financial Business

I. Supplementary Demands for Grants for the year 1997-98

On December 19, 1997 Minister for Finance laid the Supplementary Demands for Grants for the year 1997-98 in the House. The discussion and voting on Supplementary Demands for Grants took place on 22-12-1997. 17 members including Minister for Finance participated in the discussion.

The Kerala Appropriation (No. 4) Bill, 1997 in respect of Supplementary Demands for Grants for the year 1997-98 was introduced in the Assembly on 23rd December, 1997 and was taken into consideration and passed on the same day.

Private Members' Business

According to the Calendar of Sittings of the Sixth Session of Tenth Kerala Legislative Assembly Private Members' Business was set down for 2 days. Of these, December 12, 1997 was set apart for transacting Private Members' Bills and December 19, 1997 was set apart for Private Members' Resolutions. But only one day's business i.e., on December 19, 1997 was transacted during the Session.

Private Members' Resolutions

The discussion on the resolution given notice by Shri Kadakkampally Surendran (authorized by Shri P. T. Kunhimohammed) which was moved on 4th April, 1997 and not completed, was resumed. Four members participated in the discussion. The resolution was passed by the House unanimously. Another resolution given notice by Shri K. C. Joseph came up before the House during the Session. 9 members participated in the discussion. The resolution was slightly amended by the Minister for Agriculture and was passed unanimously.

The third resolution given notice by Shri G. Sudhakaran was moved and the discussion was not concluded.

The House devoted 1 hour and 22 minutes for transacting the business relating to Private Members' Resolutions.

APPENDIX VI

Salient Features of Important Bills**1. *The Kerala Co-operative Societies (Second Amendment) Bill, 1997***

Government had decided to restructure the membership pattern of the District Co-operative Banks to improve their working on the basis of the recommendations of Sri E. V. Kumaran Committee constituted to study the present status of the District Co-operative Banks and to make recommendations to improve their working. As recommended by the said committee, it was also decided to constitute Arbitration Courts for settling disputes under the Kerala Co-operative Societies Act, 1969. It was, further, decided to change the composition of the Circle Co-operative Unions and the State Co-operative Union based on representations from co-operatives.

2. As the Legislative Assembly was not in session and as the proposals had to be given effect to immediately, the Kerala Co-operative Societies (Amendment) Ordinance, 1997, to amend the Kerala Co-operative Societies Act, 1969, to achieve the above objects, was promulgated by the Governor on the 2nd day of June, 1997 and published as Ordinance No. 8 of 1997 in the Kerala Gazette Extraordinary No. 717 dated the 3rd June, 1997.

3. A Bill to replace the said Ordinance by an Act of the State Legislature could not be introduced in, and passed by, the Legislative Assembly during its session which commenced on the 23rd day of June, 1997 and ended on the 29th day of July 1997, for wants of time.

4. It was subsequently decided to empower the District Co-operative Banks to grant loans to its nominal and associate members also. It was also decided to restrict the power of the Registrar of Co-operative Societies to entertain disputes referred to him till the Co-operative Arbitration Courts are constituted since constitution of such courts with necessary infrastructure may perhaps be delayed.

5. As the Legislative Assembly was not in session, the Kerala Co-operative Societies (Second Amendment) Ordinance, 1997, was promulgated by the Governor on the 2nd day of August, 1997 with the above modification to keep alive the provisions of Ordinance No. 8 of 1997 and the same was published as Ordinance No. 12 of 1997 in the Kerala Gazette Extraordinary No. 1050 dated the 3rd of August, 1997.

6. The Bill seeks to replace the said Ordinance by an Act of the State Legislature.

2. The Alkari (Amendment) Bill, 1997

The Government in their Alkari policy for the year 1997-98 have decided to make offences relating to manufacture, export, import, transport, transit, possession, storage, distribution, bottling or selling liquor in any form, without permit or licence, cognizable, non-bailable and non-compoundable and also to enhance the punishment for offences under the Alkari Act. In order to give effect to above proposal, amendments to the various provisions of the Alkari Act were necessary.

2. As the Legislative Assembly was not in session and the above proposals had to be given effect to immediately, the Alkari (Amendment) Ordinance, 1997 was promulgated by the Governor on the 2nd day of June, 1997 and the same was published as Ordinance No. 7 of 1997 in the Kerala Gazette Extraordinary No. 733 dated 3rd June, 1997.

3. A Bill to replace the said Ordinance by an Act of the Legislature could not be introduced in, and passed by, the Legislative Assembly of the State of Kerala during its session which commenced on the 23rd day of June, 1997 and ended on the 29th day of July, 1997.

4. Subsequently, it was decided to empower the Assistant Public Prosecutors also to oppose bail applications of the offenders under the Alkari Act. It was also decided to make provision in the Act enabling the competent Magistrates to initiate action based on the report of the Alkari Inspector as if it were complaints made before them in accordance with the provisions of the Code of Criminal Procedure, 1973. It was further decided to substitute the words "competent court" for the word "Magistrate" in certain provisions of the Act consequent on the enhancement of different punishments under the Act.

5. In order to keep alive the provisions of Ordinance No. 7 of 1997, with the above modifications, the Alkari (Amendment) Ordinance, 1997 promulgated by the Governor on the 2nd day of August, 1997 was published as Ordinance No. 13 of 1997 in the Kerala Gazette Extraordinary No. 1051 dated the 3rd August, 1997.

6. The Bill seeks to replace Ordinance No. 13 of 1997 by an Act of the State Legislature.

3. The Pre-Degree Course (Abolition) Bill, 1997

The University Grants Commission has been continuously pressing the Government of Kerala to abolish Pre-Degree Course in the Universities in the State. All the other State Governments in India have already abolished pre-Degree Course by accepting 10+2 system of school education. The 10+2

system is the general system of school education in India. In accordance with the national education policy to improve standards of higher education, the Government of Kerala had decided to abolish the Pre-Degree Course in the Universities in the State in a phased manner with effect from the academic year 1997-98 and to make alternative arrangements for the establishment of more number of higher secondary schools in the State.

2. As the Legislative Assembly was not in session and as the above proposal had to be given effect to immediately, the Pre-Degree Course (Abolition) Ordinance, 1997 was promulgated by the Governor of Kerala on the 2nd day of June 1997 and the same was published as Ordinance No.5 of 1997 in the Kerala Gazette Extraordinary No. 715 dated the 3rd June, 1997.

3. A Bill to replace the said Ordinance by an Act of the State Legislature could not be introduced in and passed by the Legislative Assembly during its session which commenced on the 23rd day of June, 1997 and ended on the 29th day of July, 1997.

4. In order to keep alive the provisions of Ordinance No. 5 of 1997, the Pre-Degree Course (Abolition) Ordinance, 1997 was promulgated by the Governor on the 2nd day of August, 1997 and the same was published as Ordinance No. 10 of 1997 in the Kerala Gazette Extraordinary No. 1048 dated the 3rd August, 1997.

5. The Bill seeks to replace Ordinance No. 10 of 1997 by an Act of the State Legislature.

4. *The Kerala Public Libraries (Kerala Granthasala Sangham) Amendment Bill, 1997*

Sub-section (1) of section 4 of the Kerala Public Libraries (Kerala Granthasala Sangham) Act, 1989, provides that the term of office of the members of the State Library Council, other than the ex-officio members, shall be three years from the date on which the Government notifies the constitution of the State Library Council in the Gazette. The term of the members of the State Library Council, other than the ex-officio members, thus expired on the 26th day of April, 1997. But as per the proviso to the said sub-section, they can continue to hold office until their successors assume office. From experience Government found that a period of more than one year is necessary to complete the election process from the lowest level of Taluk Library Unions to the highest level of State Library Council, in the State. Further, election in every three years will cause undue hardship and severe strain to the State exchequer. Again, the elected body will get only a short period to chalk out their ideas and programmes

Government, therefore, considered it necessary to extend the term of office of the members of the State Library Council, other than *ex-officio* members as four years, instead of three years as provided in the Act, as applicable to the members in office of the State Library Council also. Amendment to the Act referred to above was necessary to give effect to the proposal.

2. As the Legislative Assembly was not in session and as the proposal had to be given effect to immediately, the Kerala Public Libraries (Kerala Granthasala Sangham) Ordinance, 1997, was promulgated by the Governor on the 20th day of May 1997 and the same was published as Ordinance No. 4 of 1997 in the Kerala Gazette Extraordinary No. 653 dated the 22nd May, 1997.

3. A Bill to replace Ordinance No. 4 of 1997 by an Act of the State Legislature could not be introduced in, and passed by, the Legislative Assembly during its session which commenced on the 23rd day of June, 1997 and ended on the 29th day of July, 1997.

4. Subsequently, Government have decided to extend the term of office of the members of the District Library Councils and Taluk Library Unions also as four years from the present term of three years, consequent to the extension of the term of office of the members of the State Library Council.

5. In order to keep alive the provisions of Ordinance No. 4 of 1997 with the above modifications, the Kerala Public Libraries (Kerala Granthasala Sangham) Amendment Ordinance, 1997 was promulgated by the Governor of Kerala on the 3rd day of August, 1997 and the same was published as Ordinance No. 11 of 1997 in the Kerala Gazette Extraordinary No. 1049 dated the 3rd August, 1997.

6. The Bill seeks to replace Ordinance No. 11 of 1997 by an Act of the State Legislature.

5. The Calicut University (Amendment) Bill, 1997

On the establishment of the Kannur University by the Kannur University Act, 1996, the provisions of the Calicut University Act, 1975 ceased to apply in respect of the areas coming within the territorial limits of the Kannur University. The Senate of the Calicut University was reconstituted without excluding the territorial limit of the Kannur University. The composition of the Senate of the Calicut University so constituted was not in accordance with the provisions of the Calicut University Act, 1975, as modified by the Kannur University Act, 1996, and hence illegal. The term of the recently resolved Syndicate of the Calicut University had already expired and the reconstitution of the Syndicate will take some more time.

2. The Senate and Syndicate of the Calicut University were not exercising the powers or discharging the duties or performing any functions ascribed to them by the Calicut University Act, 1973 and the Statutes made thereunder. Under the circumstances, the continuance of the Senate and the Syndicate of the University was not in the interests of the University and of the public and accordingly Government decided to dissolve the said authorities and to empower the Chancellor to constitute the said authorities, by nomination, till their reconstitution in accordance with the provisions of the Calicut University Act, 1973. It was also decided to confer power on the Chancellor, by written order, to annul any proceeding of the officers of the University also which are not in conformity with the provisions of the Act or the Statute, the Ordinances, the Regulations, the rules or the bye-laws made thereunder. Further, it was considered necessary to confer power on the Chancellor to suspend, dismiss or dissolve any authority of the University where he deems it necessary in the public interest or in the interest of the proper functioning of the University and to constitute such authorities, by nomination for the interim administration of the University. Government have also decided to prescribe an upper age limit for holding the office of the Vice-Chancellor as in the case of other Universities in the State.

3. As the Legislative Assembly of the State of Kerala was not in session and as the above proposals had to be given effect to immediately, the Calicut University (Amendment) Ordinance, 1997, was promulgated by the Governor on the 2nd day of June, 1997 and published as Ordinance No. 6 of 1997.

4. A Bill to replace Ordinance 6 of 1997 by an Act of the State Legislature was published as Tenth Kerala Legislative Assembly Bill No. 83. But the Bill could not be introduced in, and passed by, the Legislative Assembly of the State of Kerala during its session which commenced on the 23rd day of June, 1997 and ended on the 29th day of July, 1997.

5. In order to keep alive the provisions of Ordinance 6 of 1997, the Calicut University (Amendment) Ordinance, 1997 was promulgated by the Governor of Kerala on the 2nd day of August, 1997 and published as Ordinance No. 9 of 1997 in the Kerala Gazette Extraordinary No. 1047 dated the 3rd August, 1997.

6. Sub-section (2) of section 5 of Ordinance No. 9 of 1997 provides that the dissolved Senate and Syndicate of the Calicut University shall be reconstituted in accordance with the provisions of the Calicut University Act, 1973, within a period of six months from the date of dissolution of those authorities. As it is not practicable to conduct elections to the said authorities after completing all the process for election within a period of six months, it is decided to extend the time limit as 'one year' instead of 'six months'.

7. The Bill seeks to replace Ordinance No. 9 of 1997 by an Act of the State Legislature, with the above modification.
