ശ്രീ. വി.ടി. ബൽറാം :

1. In rule 4(a) wherever the figures "10%" come, substitute the figure "5%".

പ്രൊഫ. ആബിദ് ഹുസൈൻ തങ്ങൾ :

2. In rule 4(d), the word "Quinquennial" shall be substituted by 'Periodical" and the word "Five" shall be substituted by "Three".

3. In rule 4(d) for the words "the review of cadre strength of the KAS shall be done once in five years or as and when decided by government", "the review of cadre strength of KAS shall be done once in Ten years" shall be substituted.

4. Rule 5 (Reservation of appointment) modified as "The rules of Reservation of Appointment (General Rules 14-19) shall apply to appointment by direct

recruitment to KAS envisaged in Stream I, Stream II and Stream III under Rule12-Method of appointment and qualification.”

5. Rule 5 shall be recast as follows

“5. Reservation of appointment

The rules of Reservation of appointment (General Rules 14-17) shall apply to appointment by direct recruitment, by transfer recruitment and by transfer appointment to KAS envisaged in Stream I, Stream II and Stream III under Rule12 (Method of appointment and qualification) respectively.

Provided that the quota reserved to the reservation communities shall be maintained

Provided further that the total number of appointment against the reservation quota shall be assessed with quinquennial review under sub clause (d) of rule 4”

6. In rule 5, after the word “Stream I”, the words “Stream II” and “Stream III” shall be added.

7. In rule 5, after the word and alphabet “Stream 1”, the words and alphabets “Stream II” and “Stream III” shall be inserted.

8. In rule 7,7(j), 7(l), 7(m), 7(n), 7(o), 7(r), the word “Quinquennial” shall be substituted by ‘Periodical”.

- 9. Rule 7(o) shall be deleted.
- 10. In rule 9(f) for the words "date of the order of his first appointment to KAS", the words "date of PSC advice to KAS" shall be substituted.

- 11. In rule 12 column 2 "Manner of appointment" shall be modified in Stream II and Stream III as follows:-
 - Stream II By Direct Recruitment (from regular employees or approved probationers in any Government Departments or Constitutional Bodies)
 - Stream III By Direct Recruitment (From candidates holding 1st Gazetted post or above in Departments in the Schedule I and equivalent posts in Common Categories listed in Schedule I)

- 12. In rule 12(a), in column 2 against "Stream II" for the word "Transfer ", the word "Direct" shall be substituted.

- 13. In rule 12, column 2 against "Stream II" for the words "By Transfer Recruitment ", the words "By Direct Recruitment " shall be substituted.

14. In rule 12 (a) column 2 against Stream 2 after the word "Departments" the words "or Constitutional Bodies" shall be inserted.

15. In column 3 against "Stream II", for the words "the Departments in Schedule I", the words "any Government Department" shall be substituted.
16. In column 2 against Stream III, "By Transfer appointment (from candidates holding 1st Gazetted post or above in Departments in the Schedule I and equivalent post in Common Categories listed in Schedule I)" shall be substituted by "By Transfer recruitment (from candidates holding 1st Gazetted post or above in any Government Department)"

17. In rule 12, column 2 against "Stream III" for the word "By Transfer Appointment ", the word "Direct Recruitment " shall be substituted.

18. In the Table under rule 12(a) category, Stream III against in Column (2), after the words "By Transfer Appointment" the following words and bracket shall be substituted as follows;
 "(from Gazetted Officers of any Government Departments)"
19. In rule 12(b) after the words and bracket "(from all Government Departments)", the following words shall be substituted

"By Transfer Appointment from Gazetted Officers of any Government Departments"

20. In rule 12(c)(i) after the word, alphabet and bracket "(Stream 2)" the following words shall be substituted;
 "(3) By Transfer Appointment from Gazetted Officers of any Government Departments (Stream 3) respectively"
21. In rule 12(c)(v) after the words and symbol "By Transfer Appointment -", the following words shall be substituted
 "from Gazetted Officers of any Government Department."

22. Rule 12(c)(v) shall be deleted.

23. After 12(c) the following shall be inserted
 "(d) In the case of Stream 2,3 a review in every 3 year shall be made to ensure proper representation of reservation communities"

24. In rule 13(b) the figure "40" shall be substituted by the figure "50".

25. In rule 14(b) after the word and symbol "and (iii)" the following words shall be substituted
 "By Transfer Appointment from Gazetted Officers of any Government Departments"

26. In rule 14(c), after the word "Commission" the words "once in three years" shall be added.

29 In Schedule I item 30 common categories the following shall be deleted
"Administrative Officer, Accounts Officer, Financial Assistant"
