**മറുപടി:** 2017 ജനുവരി 1 മുതൽ 2026 മെയ് 31 വരെ സംസ്ഥാനത്താകെ 196 കേസുകൾ യു.എ.പി.എ. ആക്ട് പ്രകാരം രജിസ്റ്റർ ചെയ്തിട്ടുണ്ട്. വർഷം തിരിച്ചുള്ള കേസുകളുടെ എണ്ണം അനുബന്ധം 1 ആയി ചേർക്കുന്നു. ഇതിൽ 135 കേസുകൾ അന്വേഷണാവസ്ഥയിലാണ്. 30 കേസുകളുടെ അന്വേഷണം പൂർത്തിയായി ചാർജ്ജ് ഷീറ്റ് ബഹു.കോടതിയിൽ സമർപ്പിച്ചിട്ടുള്ളതാണ് (സ്റ്റിംഗ് ചാർജ്ജ് ഉൾപ്പെടെ). അന്വേഷണം പൂർത്തിയായ 30 കേസുകളിൽ 22 കേസുകളിൽ യു.എ.പി.എ. ആക്ട് ഒഴിവാക്കിയാണ് ബഹു. കോടതിയിൽ കുറ്റപത്രം സമർപ്പിച്ചിട്ടുള്ളത്. 23 കേസുകൾ റഫർ/ ക്ലോസ് ചെയ്തിട്ടുള്ളതും 8 കേസുകൾ അന്വേഷണത്തിനായി മറ്റ് ഏജൻസികൾക്ക് കൈമാറിയിട്ടുള്ളതുമാണ്. കേസുകളുടെ എഫ്.ഐ.ആർ. നമ്പർ, തീയതി, പോലീസ് സ്റ്റേഷൻ, വകുപ്പുകൾ എന്നീ വിവരങ്ങൾ അനുബന്ധം 2 ആയി ചേർക്കുന്നു.
